
Sir/Madam,

Sub: Proposal for Transfer of Environmental Clearance of Telijore River Sand Quarry over an area of 3.358 Ha at Village Telijore under Balisankara Tahasil, Dist-Sundargarh, Odisha from the name Tahasildar Balisankara to Sri Ajaya Kumar Patel, the lessee/successful bidder -reg.

Sir/Madam

This has reference to your online application no. SIA/OR/MIN/470910/2024 dated 29.04.2024, wherein you have requested for transfer of Environmental Clearance (EC) granted by SEIAA, Odisha vide letter no./EC identification No. 1177/SEIAA dt. 30.03.2021 in favour of Sri Ajaya Kumar Patel, the successful bidder.

2. The application was examined in the State Environment Impact Assessment Authority (SEIAA), Odisha in its 166th meeting held on 07.05.2024 & 08.05.2024 in accordance with the Para-11 of the EIA Notification, 2006 as amended from time to time and the following points are noted;

- (i) As submitted by the Tahasildar, Balisankara it is noted that EC was obtained for Telijore River Sand Quarry for a period of 5 years in favour of Tahasildar, Balisankara vide the above-mentioned EC letter under reference.
- (ii) Now, the said sairat source has been leased out by the Tahasildar, Balisankara to the successful bidder (lessee) for a lease period of 5 years. Hence, the Mining Officer has requested for transfer of EC in favour of Sri Ajaya Kumar Patel who is the successful bidder in this case for operationalization of the sairat source for 5 years lease period under the provision of OMMC Rules, 2016.
- (iii) Neither the PP nor the lease granting Authority have not submitted information operation status of the quarry and quantity of stone extracted from the source after obtaining EC from SEIAA, Odisha.
- (iv) Documents submitted for EC Transfer;
 - a. Form No. 7 for transfer of Environmental Clearance,
 - b. Letter no. 1363 dated 24.07.2023 of Tahasildar, Balisankara for transfer of EC to Sri Ajaya Kumar Patel as the successful bidder for Telijore River Sand Quarry.

- c. Cyber Treasury e-challan no.35BD5DF9F4 dated 10.08.2023 of Rs.1000/- towards scrutiny fee.
- d. Undertaking for accepting the terms and conditions in the original EC.
3. Transfer of Environmental Clearance (EC) letter no. 1177/SEIAA dt. 30.03.2021 of Telijore River Sand Quarry **is allowed** in favour of Sri Ajaya Kumar Patel, the successful bidder/lessee. In absence of Annual Rate of Replenishment Study (ARRS) report, the production quantity of sand **1250 cum** (i.e. 25% of the 1st year production quantity 5000 cum is allowed in EC letter) **is allowed for 2nd** year in adhoc manner. The other stipulated terms and conditions of the original EC initially granted on 30.03.2021 remain same subject to satisfactory compliance to all the stipulated terms and conditions of EC along with additional stipulation.

Additional stipulation

- (i) The validity of EC is for validity of DSR or validity of lease period whichever is earlier.
- (ii) Boundary Demarcation: - The boundary of the lease area shall be demarcated on ground at the project cost, by erecting 1.20 meter (4 feet approx.) high reinforced concrete pillars above ground, each inscribed with its serial number, distance from pillar to pillar and GPS co-ordinates by any empanelled agency of ORSAC.
- (iii) Digital Map: -A digital map (in KML format as well as PDF version) showing GPS coordinates of all boundary pillars duly countersigned by the concerned lease granting Authority Tahasildar/Mining Officer shall be submitted to SEIAA, Odisha through email at info.seiaaodisha@gmail.com.
- (iv) Intimation of EC: -The copies of the EC shall be sent to the Sarpanch (s) of the concerned Gram Panchayat (s), Urban Local Bodies and relevant other Offices of the Government with a request to display the same for 30 days from the date of receipt.
- (v) Tree Plantation:-Compensatory Tree Planting (CTP) shall be carried out with minimum @100 trees per Ha. of lease area as per the approved cost norm for plantations of the State Forest Department. The Project Proponent (lease holder) shall deposit Rs.2,00,000/- with the respective District Environment Society for raising 400 plants of native species within 2 years in a suitable location adjoining to quarry.
- (vi) The PP shall expend the amount provision for EMP and submit it in six-monthly compliance report.

The Project Proponent/lessee shall uploaded/submitted six monthly EC compliance in the Parivesh Portal of MoEF & CC., Govt. of India only on half-yearly basis falling which the EC is liable to revoked.




In case, there is a change in the scope of the project, fresh Environment Clearance shall be obtained.
