The SEAC, during its 74th meeting held on 18.06.2025, observed that PP had requested to withdraw this ToR application (proposal no.SIA/WB/MIN/490139/2024) from their end and they have already applied afresh under ToR for this project (proposal no. SIA/WB/MIN/539966/2025) which was considered by the committee in the 73rd meeting (2023-2026) meeting held on 04.06.2025. The SEAC recommended ToR for this fresh proposal. Therefore, the SEAC recommended that the present proposal may be rejected and forwarded to SEIAA for rejection.
4. The SEIAA, in its meeting held on 04/07/2025, after accepting the recommendations of the State Expert Appraisal Committee (SEAC) hereby decided to Reject ToR for present proposal of M/s. Amiya Ranjan Das under the provisions of EIA Notification, 2006 and as amended thereof.
5. The application for ToR is REJECTED.
