In view of the particulars given in the Para 1 above, the project proposal interalia including Application for Amendment in EC- Form-4 were submitted to the SEAC, Odisha for an appraisal by the State Expert Appraisal Committee (SEAC) under the provision of EIA notification 2006 and its subsequent amendments.

2. The above-mentioned proposal has been considered by State Environmental Impact Assessment Authority, Odisha

(SEIAA, Odisha) in 171st meeting held on 11/07/2024 to 12/07/2024. Based on the recommendations of the State Expert Appraisal Committee, Odisha (SEAC, Odisha), information & clarifications provided by the project proponent and after detailed deliberations the Authority decided "The Authority agreed with the recommendation of SEAC and decided to reject the amendment of EC proposal as replenishment study report submitted by the PP is not accepted by SEAC due to the following reason:

Replenishment Study is defective as mentioned below -

The replenishment study was carried out by ZEOTEK Mining Solutions, which is not a ORSAC empaneled Agency. He is doing the study under "Appoviso Consultancy" (ORSAC Empaneled)

i) No detail calculation for distance in elevation (10 m interval) given. The replenished volume calculated in the study seems to be manipulated to arrive the desired volume. Hence the replenishment study is not acceptable".

Therefore the proposal for Amendment in EC is Rejected as per provision of EIA Notification, 2006 and as amended thereof.
