EXTENSION OF VALIDITY OF ENVIRONMENTAL CLEARANCE

Preamble:

Attention is invited to this Authority's letter No. SEIAA 208 MIN 2019 dated 23.07.2019 regarding the granted of Environmental Clearance for Quarrying of Building Stone Quarry at Sy No. 110, Kardu Bande Hosahalli Village, Kolar Taluk, Kolar District, Karnataka to M/s Anjaneya Quarry Works.

Further, Project Authorities have requested vide online application bearing proposal No. SIA/KA/MIN/491136/2024 dated 10.10.2024 for Extension of Validity of EC.

The State Expert Appraisal Committee (SEAC) considered the proposal during the meeting held on 29th October 2024. The Committee as per the provision in MOEF&CC OM dated 13.12.2022, after discussion decided to recommend the proposal to SEIAA to grant extension of validity of EC, till 22.07.2049 or till the validity of lease which ever is early with all other conditions remaining same as per the EC issued by SEIAA on 23.07.2019, with following consideration,

1. To grow trees all along the approach road & buffer zone during the first year of operation.
2. To carry out regular health checkup for the workers in the nearby Hospital.
3. To provide metal sheet fencing around the working area.
4. To take necessary measures to arrest noise and vibration from the quarry area.
5. To consider the CER activity submitted by proponent with a recommendation to write to the concerned recipient about the CER activity.


The Authority have considered the proposal during the meeting held on 16th December 2024 and decided to Extend the validity of EC till 22.07.2049 or till the validity of lease whichever is early with all other conditions remaining same as per the EC issued by SEIAA on 23.07.2019.

ORDER

Pursuant to the facts and circumstances in the preamble, the validity of the Environmental Clearance issued vide letter No. SEIAA 208 MIN 2019 dated 23.07.2019 in favour of M/s Anjaneya Quarry Works, Managing Partner: Sri. Byanna, Buvanahalli Belamarana Halli post, Narsapura Hobli, Kolat Taluk and District, Karnataka by the State Level Environment Impact Assessment Authority, Karnataka for the Bande Hosahalli Village, Kolar Taluk, Kolar District, Karnataka stands extended till 22.07.2049 or till the validity of lease whichever is earlier subject to the condition that all other terms and conditions of the Environmental Clearance issued vide letter No. SEIAA 208 MIN 2019 dated 23.07.2019 shall be adhered with following conditions,

1. The PP shall grow trees all along the approach road & buffer zone during the first year of operation.
2. The PP scarry out regular health checkup for the workers in the nearby Hospital.
3. The PP sprovide metal sheet fencing around the working area.
4. The PP stake necessary measures to arrest noise and vibration from the quarry area.
