EXTENSION OF VALIDITY OF ENVIRONMENTAL CLEARANCE

Preamble:

Attention is invited to this Authority's letter No. 552 MIN 2019 dated 29.11.2019 and Transfer of EC dated 28.10.2021 for Quarrying of Building Stone at Sy. No. 40/B in Chattanahalli Village, Arasikere Hobli, Harapanahalli Taluk, Davanagere District, Karnataka by Sri. Anjigeri Prasanna.

Further, Project Authorities have requested vide online application bearing proposal No. SIA/KA/MIN/495399/2024 dated 23.09.2024 for Extension of Validity of EC.

The State Expert Appraisal Committee (SEAC) considered the proposal during the meeting held on 14th & 15th October 2024. The Committee as per the provision in MOEF&CC OM dated 13.12.2022, after discussion decided to recommend the proposal to SEIAA to grant extension of validity of EC, till 28.11.2049 or till the validity of lease whichever is early with all other conditions remaining same as per the EC issued by SEIAA on 29.11.2019 and Transfer of EC issued by SEIAA on 31.08.2021., with following consideration,

1. To grow trees all along the approach road & buffer zone during the first year of operation.
2. To carry out regular health checkup for the workers in the nearby Hospital.
3. To provide metal sheet fencing around the working area.
4. To take necessary measures to arrest noise and vibration from the quarry area.
5. To consider the CER activity submitted by proponent with a recommendation to write to the concerned recipient about the CER activity.

The Authority have considered the proposal during the meeting held on 7th November 2024 and decided to Extend the validity of EC till 28.11.2049 or till the validity of lease whichever is earlier.

ORDER

Pursuant to the facts and circumstances in the preamble, the validity of the Environmental Clearance issued vide letter No. SEIAA 552 MIN 2019 dated 29.11.2019 subsequently Transfer of EC in favour of Sri Anjigere Prasanna, S/o Late Sri. A Siddalingappa, Pothalakatte, Harapanahalli Taluk, Davanagere District, Karnataka - 583125 vide letter No. SEIAA 552 MIN 2019 dated 28.10.2021 by the State Level Environment Impact Assessment Authority, Karnataka for the Building Stone Quarry Project at Part of Sy.No.40/B of Chattanahalli Village, Harapanahalli Taluk, Ballari District (2-00 Acres) stands extended till 28.11.2049 or till the validity of lease which ever is earlier subject to the condition that all other terms and conditions of the Environmental Clearance issued on SEIAA 552 MIN 2019 dated 29.11.2019 and Transfer of EC dated 28.10.2021 shall be adhered with following conditions,

1. To grow trees all along the approach road & buffer zone during the first year of operation.
