In view of the particulars given in the Para 1 above, the project proposal interalia including Form-6 were submitted to the State Level Expert Appraisal Committee (SEAC) for an appraisal by the SEAC under the provision of EIA notification 2006 and its subsequent amendments under the provision of Para 9.0 of the EIA notification 2006 and its subsequent amendments. Details in Form-6 can be accessed from the PARIVESH portal by scanning the QR Code above.
4. The brief about the reasons for an extension of validity of EC, as submitted by the Project Proponent in Form-6 and presented during SEAC is annexed to this letter as **Annexure (2)**.
5. The above-mentioned proposal has been considered by SEAC in the meeting held on 19.06.2018. The minutes of the meeting and all the project documents are available on PARIVESH portal which can be accessed by scanning the QR Code above.
6. The SEAC, in its meeting held on 19.06.2018 based on information & clarifications provided by the project proponent, the SEAC considered the proposal as 'B2' category as the unit is generating waste water less than 100 KLD and recommended to grant Environmental Clearance for production of 3.792 KLD of county Liquor with modified conditions as recommended in the SEAC meeting held on 19.06.2018 under the provision of EIA Notification, 2006 and as amended thereof.
7. The SEIAA, Odisha has examined the proposal in 183<sup>rd</sup> meeting held on 23.12.2024 in accordance with the provisions contained in the Para 9 of Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and based on the recommendations of the State Level Expert Appraisal Committee (SEAC) hereby accords Extension in Validity of Environment Clearance letter no.7639/SEIAA dated 07.12.2019 for the instant proposal for production of 3.792 KLD country liquor from manufacturing unit of M/s Polasara O.S. Shop At-Hatibadi Tahasil: Polasara, Dist: Ganjam, State: Odisha of Licensee Sri Ardhendu Sundar Sahu under the provisions of EIA Notification, 2006 and as amended thereof subject to compliance of EC conditions, general instructions issued vide EC letter dated 07.12.2019. 

## Annexure 1

### Additional EC Conditions

1. This environmental clearance (EC) is valid upto the excise license period and shall be coterminous with the period of validity of the existing Excise License.
2. The proponent shall obtain fresh environmental clearance (EC) if they shift the unit to other location and/or go for higher production capacity.
3. The PP shall implement the EMP with a budgetary allocation as proposed in the EMP report during EC application.
4. The PP shall plant some tree species like Banyan, Peepal, Neem, Jamun, Mango, Karanj, Arjun etc. as part of tree plantation campaign "*Ek Ped Ma Ke Naam*" and the details of the same shall be uploaded in the MeriLiFE Portal (<https://merilife.nic.in>).
5. The Project Proponent shall uploaded/submitted six monthly EC compliance in the Parivesh Portal of MoEF & CC., Govt. of India only falling which the EC is liable to revoked.



**1. Proposal in brief:**

- (i) The highlights of the proposal as ascertained from the application and as revealed from proceedings/discussion held during the meeting of SEAC/SEIAA, are given as under.
- (ii) This is a proposal for Extension of validity of environmental clearance for production 3.792 KLD country liquor from manufacturing unit of M/s Polasara O.S. Shop At-Hatibadi Tahasil: Polasara, Dist: Ganjam, State: Odisha.
- (iii) Documents submitted: Application in Form-6, earlier EC copy, excise license certificate.
- (iv) Environmental Clearance was issued vide letter No -.7639/SEIAA on dated 07.12.2019 validity up to the excise license period. Since then, the EC is being extended after renewal of excise license. Now, the excise license has been renewed. Therefore, the PP has requested you kindly to extend the validity of environmental clearance upto the validity of excise license to obtain the CTO to operate the unit.
- (v) The extension of validity of EC was issued on 09.08.2023 upto the lease period.
- (vi) The excise license no. 12/2019/0079 is valid from 01.04.2024 to 31.07.2024 for the said unit. Further, as per Excise Deptt. letter no. 4807 dated 30.08.2024, the license renewed upto **31.03.2025**.
- (vii) Any deficiencies/omission have been noticed in the above documents- Nil
