In view of the particulars given in the Para 1 above, the project proposal interalia including Application for Amendment in EC- Form-4 were submitted to the SEAC, Odisha for an appraisal by the State Expert Appraisal Committee (SEAC) under the provision of EIA notification 2006 and its subsequent amendments.

2. The above-mentioned proposal has been considered by State Environmental Impact Assessment Authority, Odisha

(SEIAA, Odisha) in 187th meeting held on 25/01/2025. Based on the recommendations of the State Expert Appraisal Committee, Odisha (SEAC, Odisha), information & clarifications provided by the project proponent and after detailed deliberations decided "After detailed deliberation, the authority rejected the proposal as per the recommendation of SEAC with the following observations:- A. The KML file is of Ramdaspur1 while the proposal is for Nuahata sand quarry. B. EC conditions compliance is given only for additional conditions and not for complete EC conditions. C. Replenishment study is not acceptable due to following reasons

1. No Ground Control Points Taken.
2. No Permanent bench mark is taken.
3. No error report of Drone survey given
4. Timing of Pre-Monsoon Survey (in first week of March) is not appropriate.

Hence, the proposal for Amendment in EC is Rejected as per provision of EIA Notification, 2006 and as amended thereof.
