Appraisal Committee, Odisha (SEAC, Odisha), information & clarifications provided by the project proponent and after detailed deliberations the authority decided “After detailed deliberation, the authority decided to reject the amendment of EC as recommended by SEAC due to the following reasons: - 1. In the ARSS report, the replenishment quantity is not calculated. The ARSS should show common safe workable area and Replenishment quantity should be based on that and hence the ARSS is not acceptable“.

3. Hence, the proposal is Rejected as per provision of EIA Notification, 2006 and as amended thereof.
