SEIAA in its 201st Meeting held on 29/08/2025 perused the case and minutes of the 614th meeting of SEAC held on 16/04/2025.

It is noted that original application is for mining of Limestone (Minor Minerals), capacity- 9,944.60 TPA. After deliberation, SEIAA unanimously accepted the recommendation of SEAC and decided to grant Environmental Clearance for mining of Limestone (Minor Minerals) capacity- 9,944.60 TPA in khasra no. 1/2, Area - 1.417 Hectare at Village -

Kekarabhata, Tehsil - Dabhra, District - Janjgir - Champa under the EIA Notification, 2006 (as amended) listed in Schedule 1(a) Mining of minerals under Category "B2".

3. This Environment Clearance is for mining of Limestone (Minor Minerals) capacity- 9,944.60 TPA in khasra no. 1/2, Area - 1.417 Hectare at Village - Kekarabhata, Tehsil - Dabhra, District - Janjgir - Champa, Chhattisgarh.
4. In view of the particulars given in the Para 1 above, the project proposal interalia including Form-1 (Part A and B) were submitted to the SEIAA under the provision of EIA notification 2006 and its subsequent amendments.
5. The above-mentioned proposal has been considered by State Environment Impact Assessment Authority (SEIAA) in the meeting held on 29/08/2025. The minutes of the meeting and all the Application and documents submitted are available on PARIVESH portal which can be accessed by scanning the QR Code above.
6. Details of the minerals to be mined along with production capacity and the brief on the salient features of the project as submitted by the project proponent in Form 1 (Part A and B) presented are annexed to this EC as Annexure (1).
7. The SEAC, in its meeting held on 16/04/2025, based on information & clarifications provided by the project proponent and after detailed deliberations on all technical aspects and compliance thereto furnished by the Project Proponent, recommended the proposal for grant of Environment Clearance under the provision of EIA Notification, 2006 and as amended thereof subject to stipulation of Specific and Standard EC conditions as detailed in the point below.
8. The SEIAA has examined the proposal in accordance with the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and after accepting the recommendations of the SEAC and hereby decided to grant Environment Clearance for the instant proposal under the provisions of EIA Notification, 2006 and as amended thereof subject to compliance of the Specific and Standard EC conditions as given in Annexure (2).
9. The Ministry reserves the right to stipulate additional conditions, if found necessary.
10. The Environmental Clearance to the aforementioned project is under provisions of EIA Notification, 2006. It does not tantamount to approvals/consent/permissions etc. required to be obtained under any other Act/Rule/regulation. The Project Proponent is under obligation to obtain approvals /clearances under any other Acts/ Regulations or Statutes, as applicable, to the project.
11. The PP is under obligation to implement commitments made in the Environment Management Plan, which forms part of this EC.

The Project Proponent shall submit revised approved mining plan incorporating the plan for restoration of the excavated 7.5 meter safety green belt area within one month.2. The Project Proponent shall carryout the restoration of the excavated 7.5 meter safety green belt area as given in the approved mining plan within a period of 3 months from the date of issue of EC.3. The plantation in the 7.5 meter wide safety green belt area as given in the EC shall be planted within 3 months from the date of issue of EC.4. The concerned Regional Office of CECB shall ensure the fulfillment of the above 3 conditions within the time frame indicated above, failing which the RO shall be responsible for closing the mining operation for non-fulfillment of the above conditions.

In case, it is proposed to construct a 'bypass' road, it should be so constructed that the impact of sound, dust and accidents could be appropriately mitigated. 7. Vehicular emissions shall be kept under control and regularly monitored. All the vehicles engaged in mining and allied activities shall operate only after obtaining 'PUC' certificate from the authorized pollution testing centers. 8. Water sprinkling arrangement shall be provided to reduce the impact of air pollution. 9. Post environmental closure third party monitoring by reputed instituted in air quality, water, land & soil etc shall be carried out and analyses with EMP measures at regular interval. Regular monitoring of ground water level and quality shall be carried out in and around the mine lease area by establishing a network of existing wells and constructing new piezometers during the mining operations. The monitoring of ground water levels shall be carried out four times a year i.e. pre-monsoon, monsoon, post-monsoon and winter. The ground water quality shall be monitored once a year, and the data thus collected shall be sent regularly to MOEFCC/RO. 2. If any river, ponds and lakes close to the mine lease area, monitoring of water quality upstream and downstream of river including ponds, lakes shall be carried out once in six months and record of monitoring data shall be maintained and submitted to the Ministry of Environment, Forest and Climate Change/Regional Office. 3. Ground water, excluding mine water, shall not be used for mining operations. Rainwater harvesting shall be implemented for conservation and augmentation of ground water resources. 4. The project proponent shall not alter major water channels around the site. Appropriate embankment shall be provided along the side of the river/nallah flowing near or adjacent to the mine. The embankment constructed along the river/nallah boundary shall be of suitable dimensions and critical patches shall be strengthened by stone pitching on the river front side, stabilized with plantation so as to withstand the peak water pressure preventing any chance of mine inundation. 5. Garland drains (of suitable size, gradient and length) around the critical areas i.e. mine shaft and low lying areas, shall be designed keeping at least 50% safety margin over and above the peak sudden rainfall and maximum discharge in the area adjoining the mine sites. The sump capacity shall also provide adequate retention period to allow proper settling of silt material of the surface runoff. The water pumped out from the mine, after siltation, shall be utilized for watering the mine area, roads, green belt development etc. The drains shall be regularly desilted particularly after monsoon and maintained properly. 6. The water pumped out from the mine, after siltation, shall be utilized for industrial purpose viz. watering the mine area, roads, green belt development etc. The drains shall be regularly desilted particularly after monsoon and maintained properly. 7. Adequate groundwater recharge measures shall be taken up for augmentation of ground water. The project authorities shall meet water requirement of nearby village(s) in case the village wells go dry due to dewatering of mine. 8. The surface drainage plan including surface water conservation plan for the area of influence affected by the said mining operations shall be prepared, considering the presence of any river/rivulet/pond/lake etc., with impact of mining activities on it, and implemented by the project proponent. The surface drainage plan and/or any diversion of natural water courses shall be as per the provisions of the approved Mining Plan/ EIA-EMP submitted to this Ministry and the same should be done with due approval of the concerned State/GoI Authority. The illumination and sound at night at project sites disturb the villages in respect of both human and animal population. Consequent sleeping disorders and stress may affect the health in the villages located close to mining operations. Habitations have a right for darkness and minimal noise levels at night. PPs must ensure that the biological clock of the villages is not disturbed; by orienting the floodlights/ masks away from the villagers and keeping the noise levels well within the prescribed limits for day light/night hours.</p>


