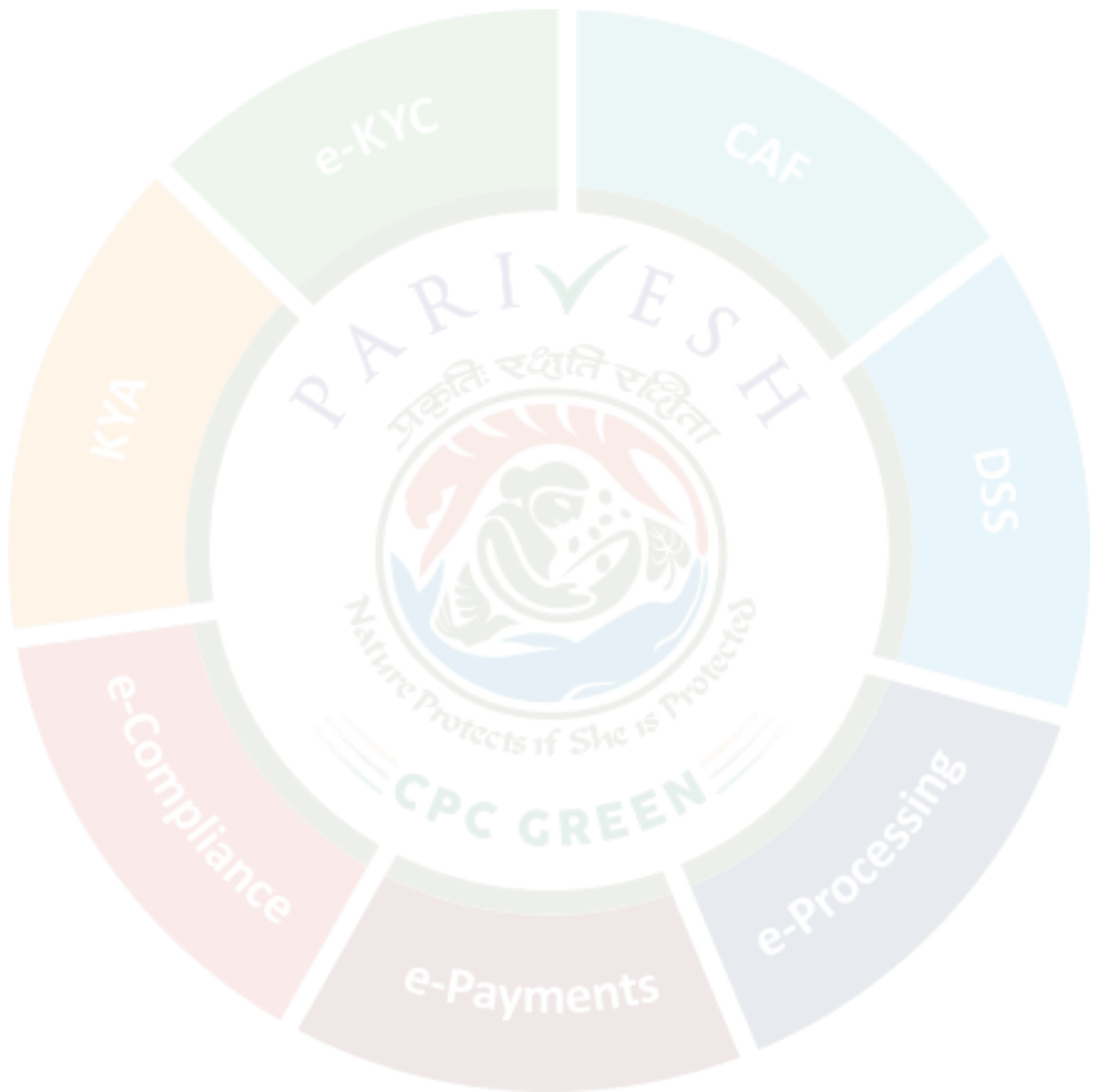

Sir/Madam,

This has reference to your online application no. SIA/OR/MIN/460336/2024 dated 30.01.2024, wherein you have requested for amendment (i.e. amendment of EC regard to annual production of sand as per replenishment study report) of Environmental Clearance (EC) granted by SEIAA, Odisha vide letter no./EC Identification No. 9362/SEIAA dt. 27.10.2020 in favour Sri. Rakash Kumar Agrawal, the successful bidder/lessee.

2. The application was examined in the State Environment Impact Assessment Authority (SEIAA), Odisha in its 165th meeting held on 30.04.2024 & 02.05.2024 in accordance with the EIA Notification, 2006 as amended from time to time and the following points are noted;

- (i) This is a proposal for amendment of EC of Kirtipur Sand Quarry over an area of 12.355 Acres or 5.00 Hectares in village Kirtipur under Sonepur tahasil of Subarnapur district.
- (ii) The project proponent has obtained EC from SEIAA, Odisha vide EC letter no. EC Identification No. – 10357/SEIAA dt. 17.12.2020 and transfer of EC was issued dt. 08.11.2023 for Kirtipur Sand Quarry over an area of 12.355 Acres or 5.00 Hectares in village Kirtipur under Sonepur tahasil of Subarnapur district.
- (iii) During EC application the PP has submitted required documents along with mining plan where it is mentioned that mineable reserve of the proposed sand was 41519 cum with depth of sand deposition was 1.0 meter and proposed for annual extraction-2000 cum.
- (iv) The SEIAA allowed the production quantity of sand 2000 cum for the 1st year lease with depth of mining 1.0 meter.
- (v) There is an EC conditions point no. 9.1 to 9.2 in page no. 03 that “Pending carrying out of the study & submission of the report, this clearance is being granted in an adhoc manner and is liable to be revoked after one year i.e. after November 2021, if satisfactory replenishment study report is not submitted.”
- (vi) The PP has mentioned that 2000 cum of sand has been extracted from the source in 1st year.
- (vii) The replenishment study was done by the M/s. Areal Constructions & Geo -India Services, the ORSAC empanel agency with mentioned that the Pre-Monsoon Standard

Elevation = 111.5314 and Post-Monsoon Standard Elevation = 112.4961 and quantity of sand replenished is 34082.85 cum and proposed production is 20449 cum.

- (viii) Documents submitted for amendment of EC;
- Form No. 4 for amendment of Environmental Clearance,
 - Replenishment study report
3. The proposal was placed in SEAC meeting held on 26.02.2024 and the SEAC decided to recommend the proposal as per the replenishment study report submitted. The replenished volume of sand is 28186.4849 cum which is recommended for extraction for next year subjected to approval of Modified Mining Plan from competent authority of Mining & Geology Department, Odisha.
4. Amendment of Environmental Clearance (EC) letter no./Identification no. 9362/SEIAA dt. 27.10.2020 issued for Kutasinga River Sand Quarry in favour of Sri. Rakash Kumar Agrawal is **allowed** for extraction quantity of sand **28186 cum per annum** for rest of the lease period i.e. for 2nd year, 3rd year, 4th year and 5th year. The other stipulated terms and conditions of the original EC initially granted remains same subject to satisfactory compliance to all the stipulated terms and conditions of EC along with following additional stipulation:

Additional stipulation

- The project proponent is required to obtained modified mining plan from the Mines & Geology Deptt. Govt. of Odisha & revision of lease sanction order from the competent Authority on the basis of approved extraction quantity of sand i.e. 28186 cum/annum as ARRS report.
- The PP is required to carry out the Annual rate of replenishment study (ARRS) through ORSAC empanel agency in subsequent year and submit the report to SEIAA, Odisha.
- The validity of EC is for validity of DSR or validity of lease period whichever is earlier.
- The Project Proponent (lease holder) shall deposit Rs.2,50,000/-, with the respective District Environment Society for raising 500 plants (minimum @100 trees per Ha) of native species within 2 years in a suitable location adjoining to quarry.
- The PP will implement the EMP with a budgetary allocation as proposed in the EMP report during EC application.

The Project Proponent shall uploaded/submitted six monthly EC compliance in the Parivesh Portal of MoEF & CC., Govt. of India only within six months (06) from date of issue of transfer of EC, falling which the EC is liable to revoked.

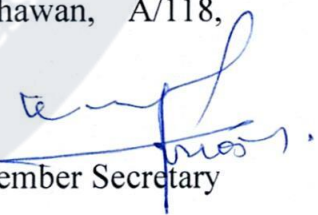
