In view of the particulars given in the Para 1 above, the project proposal interalia including Form-1(Part A and B) were submitted to the Ministry for an appraisal by the State Environment Impact Assessment Authority(SEIAA) and Appraisal Committee (SEAC) in the Ministry under the provision of EIA notification 2006 and its subsequent amendments.

The State Level Expert Appraisal Committee (SEAC) examined the proposal in its meeting held on 29.10.2024 and based on the information furnished by the proponent, the presentation made by the Environmental Co-ordinator of M/s. Ampl Environ Pvt. Ltd., Hyderabad, the committee recommended the proposal for grant of EC under the provision of EIA

Notification, 2006 and as amended thereof.

The minutes of the meeting and all the Application and documents submitted [(viz. Form-1 Part A, Part B, Part C EIA, EMP)] are available on PARIVESH portal which can be accessed by scanning the QR Code above.

The SEIAA has examined the proposal in its meeting held on 06.11.2024 and after accepting the recommendations of the State Level Expert Appraisal Committee (SEAC) in detail approved the project for issue of Environmental Clearance subject to submission of bank guarantee of Rs. 1.00 lakh, notarized affidavit. Hence, decided to grant EC for instant proposal of M/s. Sai Srinivasa Laxmi Stone Crusher under the provision of EIA Notification, 2006 and as amended thereof and with stipulation of specific and general conditions as detailed in Annexure (1). The proponent vide lr. dt: 08.11.2024 submitted Bank Guarantee & Affidavit as sought by SEIAA.

The Ministry reserves the right to stipulate additional conditions, if found necessary.

The EC to the aforementioned project is under provisions of EIA Notification, 2006. It does not tantamount to approvals/consent/permissions etc. required to be obtained under any other Act/Rule/regulation. The Project Proponent is under obligation to obtain approvals /clearances under any other Acts/ Regulations or Statutes, as applicable, to the project.

### 3. General Instructions:

1. The project proponent shall prominently advertise it at least in two local newspapers of the District or State, of which one shall be in the vernacular language within seven days indicating that the project has been accorded environment clearance and the details of SEIAA website where it is displayed.
2. The copies of the environmental clearance shall be submitted by the project proponents to the Heads of local bodies, Panchayats and Municipal Bodies in addition to the relevant offices of the Government who in turn must display the same for 30 days from the date of receipt.
3. The project proponent shall have a well laid down environmental policy duly approved by the Board of Directors (in case of Company) or competent authority, duly prescribing standard operating procedures to have proper checks and balances and to bring into focus any infringements/deviation/violation of the environmental / forest / wildlife norms / conditions.
4. Action plan for implementing EMP and environmental conditions along with responsibility matrix of the project proponent (during construction phase) and authorized entity mandated with compliance of conditions (during operational phase) shall be prepared. The year wise funds earmarked for environmental protection measures shall be kept in separate account and not to be diverted for any other purpose. Six monthly progress of implementation of action plan shall be reported to the Ministry/Regional Office along with the Six-Monthly Compliance Report.
5. Concealing factual data or submission of false/fabricated data may result in revocation of this environmental clearance and attract action under the provisions of Environment (Protection) Act, 1986.
6. The Regional Office of this SEIAA shall monitor compliance of the stipulated conditions. The project authorities should extend full cooperation to the officer (s) of the Regional Office by furnishing the requisite data / information/monitoring reports.
7. Any appeal against this EC shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.

Earlier, EC was granted for mining of Stone & Metal with a production of 20,000 m<sup>3</sup>/annum for an extent of 0.80 Ha vide order dt: 26.09.2017 by the DEIAA, Jagityal District considering the individual mine lease area / cluster area being less than 25 Ha. Which was considered under B2 category till 13.09.2018 only (as per Hon'ble NGT Order dt: 13.09.2018 in O.A. No. 186 of 2016). Subsequently, as per directions of the MoEF & CC, GoI w.r.t. appraisal / re-appraisal of ECs issued by DEIAAs, the proponent submitted afresh for EC (appraisal / re-appraisal). The application was granted considering viz., Quarry lease granted by DDM&G, Warangal vide Procds., dt: 31.03.2016; Execution of Quarry lease deed granted vide Procds. dt:28.06.2016 by the ADM&G, Karimnagar District w.e.f. 28.06.2016 to 27.06.2031; Scrutinized/Approved Mining Plan dt:20.12.2023; Lr.dt. 21.10.2024 of ADM&G, Jagityal District furnishing details of mines in cluster i.e., within 500 mts from the proposed mine lease area; Lr.dt. 21.10.2024 of ADMG, Jagityal District furnishing the dispatch / production details of mine; The proponent obtained CFO vide order dt:23.12.2022 which is valid up to 30.11.2027 from TGPCB.

The total cost of the project is Rs. 25.0 Lakhs. The proponent is proposing budget for environmental protection towards capital cost: Rs. 3.14 lakhs and recurring cost: Rs. 2.53 lakhs/annum.
