1. In view of the particulars given in the Para 1 above, the project proposal interalia including Form-1(C)/ EIA & EMP Reports were submitted to the Ministry for an appraisal by the SEIAA under the provision of EIA notification 2006 and its subsequent amendments.

2. The above-mentioned proposal has been considered by SEIAA in the meeting held on 10/12/2024. The minutes of the meeting and all the Application and documents submitted [(viz. Form-1 Part A, Part B, Part C EIA, EMP)] are available on PARIVESH portal which can be accessed by scanning the QR Code above.

The SEAC, in its meeting held on 20/11/2024, based on information & clarifications provided by the project proponent (PP) observed that the plot area for the proposed project as per the geo-coordinates mentioned in the coordinate map uploaded by the PP falls outside the potential mining zone recorded in the approved District Survey Report (DSR) of Birbhum district. After detailed deliberations SEAC recommended the proposal for Rejection of Environment Clearance and forwarded to SEIAA for rejection under the provision of EIA Notification, 2006 and as amended thereof.
4. The SEIAA has examined the proposal in accordance with the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and after accepting the recommendations of the State Expert Appraisal Committee hereby decided to Reject Environment Clearance for instant proposal of M/s. BABLI DEY under the provisions of EIA Notification, 2006 and as amended thereof.
5. **Application for EC is REJECTED.**
