Sir/Madam,

This has reference to your online application no. SIA/OR/MIN/459491/2024 dated 21.01.2024, wherein you have requested for amendment (i.e. amendment of EC regard to annual production of sand as per replenishment study report) of Environmental Clearance (EC) granted by SEIAA, Odisha vide letter no./EC identification No. EC22B001OR167037 dt. 03.06.2022 in favour of Smt. Chinmayee Muduli, the lessee/successful bidder.

2. The application was examined in the State Environment Impact Assessment Authority (SEIAA), Odisha in its 157th meeting held on 22.02.2024 in accordance with the EIA Notification, 2006 as amended from time to time and the following points are noted;

- (i) This is a proposal for amendment of EC of Uttampur Sand Quarry over an area of 14.00 Acres or 5.67 ha at village-Uttampur, Tahasil- Sadar Cuttack, District-Cuttack.
- (ii) The project proponent has obtained EC from SEIAA, Odisha vide EC letter no. EC22B001OR167037 dt. 03.06.2022 for Uttampur Sand Quarry over an area of 14.00 Acres or 5.67 ha at village-Uttampur, Tahasil- Sadar Cuttack, District-Cuttack.
- (iii) During EC application the PP has submitted required documents along with mining plan where it is mentioned that mineable reserve of the proposed

- sand was 166672 cum with depth of sand deposition was 2.0 meter and proposed for annual extraction-20000 cum.
- (iv) The SEIAA allowed 11000 cum of sand for 1st year production with depth of mining 1.0 meter.
- (v) There is an EC conditions point no. 7.1 to 7.2 in page no. 04 that "Pending carrying out of the study & submission of the report, this clearance is being granted in an adhoc manner and is liable to be revoked after one year i.e. after Nov 2022, if satisfactory replenishment study report is not submitted."
- (vi) The PP has mentioned the quantity of sand extracted 11000 cum in the year 1st year & 9000 cum in 2nd year.
- (vii) The replenishment study was done by the AREAL CONSTRUCTIONS & GEO-INDIA SERVICES, the ORSAC Empanelment Agencies with mentioned that the pre-monsoon Standard Elevation = 22.82519608 and post-monsoon Standard Elevation = 24.02519608 and quantity of sand replenished is 48427 cum and proposed production is 29056 cum/annum.
- (viii) Both Pre monsoon (12.06.2023) and Post Monsoon (22.11.2023) has been carried out by Drone survey method.
- (ix) Available replenishment mineable reserve after post monsoon in common workable area of 40355.907sqm is 48427.0884cum and 60% of replenishment mineable reserve is 29056.253cum of sand.
- (x) Documents submitted for amendment of EC;
- a. Form No. 4 for amendment of Environmental Clearance,
- b. Replenishment study report
3. The proposal was placed in SEAC meeting held on 29.01. 2024 and the SEAC decided to recommend the proposal for Mod EC as per the replenished sand quantity i.e., 20000 cum of sand.
4. Amendment of Environmental Clearance (EC) letter no./Identification no. EC22B001OR167037 dt. 03.06.2022 issued for Uttampur Sand Quarry in favour of Smt. Chinmayee Muduli is allowed for extraction quantity of sand i.e. **20000 cum/annum** for the rest of the lease period i.e. for the 3rd year, 4th year and 5th year. The other stipulated terms and conditions of the original EC initially granted remains same subject to satisfactory compliance to all the stipulated terms and conditions of EC along with following additional stipulation:

Additional stipulation

- (i) The PP is required to carry out the Annual rate of replenishment study (ARRS) through ORSAC empanel agency in subsequent year and submit the report to SEIAA, Odisha.
- (ii) The validity of EC is for validity of DSR or validity of lease period whichever is earlier.
- (iii) The Project Proponent (lease holder) shall deposit Rs.3,00,000/-, with the respective District Environment Society for raising 600 plants (minimum @100 trees per Ha) of native species within 2 years in a suitable location adjoining to quarry.

- (iv) The PP shall implement the EMP cost is mentioned in the EMP report and submitted it during EC application.

The Project Proponent shall uploaded/submitted six monthly EC compliance in the Parivesh Portal of MoEF & CC., Govt. of India only within six months (06) from date of issue of transfer of EC, falling which the EC stands automatically revoked.

In case, there is a change in the scope of the project, fresh Environment Clearance shall be obtained.


