EXTENSION OF VALIDITY OF ENVIRONMENTAL CLEARANCE

Preamble:

Attention is invited to this Authority's letter No. SEIAA 298 MIN 2019 dated 05.07.2019 regarding the granted of Environmental Clearance for Building Stone Quarry Project at Doddakereyuru Village, H.D. Kote Taluk, Mysore District (4-20 Acres) to Sri C. Shivakumar S/o. Late Chikkaramegowda

Further, Project Authorities have requested vide online application bearing proposal No. SIA/KA/MIN/480441/2024 dated 10.08.2024 for Extension of Validity of EC.

The State Expert Appraisal Committee (SEAC) considered the proposal during the meeting held on 29th October 2024 and after discussion decided to recommend the proposal to SEIAA to grant extension of validity of EC, till 05.07.2049 or till the validity of lease whichever is early with all other conditions remaining same as per the EC issued by SEIAA on 05.07.2019, with following consideration,

Lt Chikkaramegowda, No. 466, A-1 Block, 15th Cross, 3rd Main Road, Vijayanagara 3rd Stage, Mysore District by the State Level Environment Impact Assessment

Authority, Karnataka for the Quarrying of Building Stone at Sy. No. 84/3, 141 & 142/2 in Doddakereyuru Village, H. D Kote Taluk, Mysore District, Karnataka stands extended till 05.07.2049 or till the validity of lease whichever is earlier subject to the condition that all other terms and conditions of the Environmental Clearance issued vide letter No. SEIAA 298 MIN 2019 dated 05.07.2019 shall be adhered with following conditions,
