In view of the particulars given in the Para 1 above, the project proposal interalia including Form-7 were submitted to the SEIAA under the provision of Para 11 of the EIA notification 2006 and its subsequent amendments. Details in Form 7 can be accessed on PARIVESH portal by scanning the QR Code above.

The SEIAA has examined the requisite information/documents required for transfer of EC in accordance with the provisions contained in the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and hereby accords Transfer of EC dated to **M/s. A.J. Associates** under the provisions of EIA Notification, 2006 and as amended thereof subject to compliance of EC conditions issued vide EC letter dated **06.03.2023**.

The Ministry may revoke or suspend the clearance, if implementation of any of the EC conditions is not satisfactory. The Ministry reserves the right to stipulate additional conditions, if found necessary.

The Project Proponent is under obligation to implement the commitments made in the Environment Management Plan, which was granted in the earlier EC issued vide dated **06.03.2023**.

The SEIAA, TS issued EC Order No: EC23B001TG117216, dt. 06.03.2023, to Sri. Pentapurthy Divakar Reddy, for mining @ 30,170.4 m³/annum with a valid period of 26 years. TGPCB CFO order dt: 17.05.2023 which is valid upto 30.09.2027.

Now, M/s. A.J. Associates vide Proposal No. SIA/TG/MIN/468883/2024, dt: 10.04.2024 informed that the Mine lease has been transferred from Sri. Pentapurthy Divakar Reddy to M/s. A.J. Associates, and submitted copy of Procds. No.4500/Q/2023, dt. 08.12.2023 of ADM&G, Hanamakonda District and an undertaking on Rs. 100/- Stamp paper for complying all statutory stipulations as per EC and E(P) Act, 1986; NOC issued by Sri. Pentapurthy Divakar Reddy, dt:14.12.2023 for transfer of EC. Hence, it was requested to transfer the EC in the name of M/s. A.J. Associates.

The above issue was examined by the State Level Environment Impact Assessment Authority (SEIAA) in its meeting held on **22.06.2024**. The Authority approved to transfer the EC order already issued in favour of Sri. Pentapurthy Divakar Reddy to M/s. A.J. Associates.

Hence, the **SEIAA, Telangana hereby transfers the EC order dt: 06.03.2023 issued in the name of M/s. A.J. Associates**, with all terms and conditions stipulated therein remain the same.
