2. The above-mentioned proposal has been considered by State Environmental Impact Assessment Authority, Odisha (SEIAA, Odisha) in 173rd meeting held on 06/08/2024 and 08/08/2024. Based on the recommendations of the State Expert Appraisal Committee, Odisha (SEAC, Odisha), information & clarifications provided by the project proponent and after detailed deliberations the Authority decided “ The Authority observed that the same lease application was submitted to SEIAA vide letter no. SIA/OR/Min/404088/2022 which has been rejected vide SEIAA letter no. 15.02.2024 as per SEAC recommendation. The PP has again submitted the same proposal through a different file no.SIA/OR/MIN/469577/2024 dated 18.04.2024. After detailed discussion, the Authority decided to reiterate its earlier decision to reject the proposal”.

Therefore, the proposal is Rejected as per provision of EIA Notification, 2006 and as amended thereof.
