This is in reference to your application submitted to SEIAA vide proposal number SIA/PB/IND1/456051/2023 dated 19/02/2024 for grant of prior Environmental Clearance (EC) to the proposed project under the provision of the EIA Notification 2006 and as amended thereof.

3. State Environment Impact Assessment Authority (SEIAA), Punjab has examined the proposal for the expansion in

existing steel manufacturing unit having capacity 1,29,600 TPA of MS Billets, 1,26,000 TPA of TMT Rebars/Wire Rod with 30 TPH Induction Furnace, 01 No. of concast and 01 No. of rolling mill to MS Billets @ 3,60,000 TPA and TMT Rebars/wire rods/ MS Strips/ Angles/Channels/ Round/ Flats @ 3,51,000 TPA by addition of 01 No. of Induction Furnace of 30 TPH and 01 of rolling mill at Village Talwara, Mandi Gobindgarh, Tehsil Amloh, District Fatehgarh Sahib, Punjab. The project is covered under Schedule 3(a) & Category 'B1' as per EIA Notification, dated 14.09.2006 and its subsequent amendments and requires appraisal at the State level.

4) State Environment Impact Assessment Authority (SEIAA), Punjab had granted Terms of Reference (TOR) vide letter no. SEIAA/MS/2023/891 dated 26.07.2023 to the project proponent.

5) The proposal has been appraised as per the procedure prescribed under the provisions of EIA Notification 14.09.2006 based on mandatory documents enclosed with the application viz Form-2, EIA, EMP, and additional documents and subsequent presentation/ clarifications made by the project proponent and his consultant to the observations of SEIAA and SEAC.

6) As per the report of the Punjab Pollution Control Board vide letter No. 29184-87 dated 24.11.2023, no construction work of the proposed project has been started at site and only boundary wall has been done at the site.

7) This is an expansion project. The details of the project, as per the application and documents/ presentation submitted by the project proponent and also as informed during the meetings of SEAC/SEIAA are as under:

8) As per undertaking given by the project proponent, no forest land and wildlife sanctuary is located in the vicinity of the project and as such, no forest clearance and NBWL permission is required. The Project Proponent informed that in the court matter pertaining to land, the Hon'ble High Court of Punjab and Haryana maintained status quo.

9) The SEAC, constituted under the provision of the EIA Notification, 2006 and comprising of Experts Members/domain experts in various fields, has examined the proposal submitted by the project proponent in the desired form along with the EMP report prepared and submitted by the Consultant accredited by the QCI/NABET on behalf of the project proponent & replies to its observations in its 277th meeting held on 01.03.2024 and 283rd meeting held on 01.04.2024. The SEAC noted that the project proponent has given an undertaking that the data and information given in the application and enclosures are true to the best of his knowledge and belief and no information has been suppressed in the report. If any part of the data/information submitted is found to be false/misleading at any stage, the project may be rejected and Environmental Clearance given, if any, may be revoked at the risk and cost of the project proponent.

10) The Committee noted that the project proponent has provided adequate and satisfactory clarifications to the observations raised by it. Therefore, the Committee decided to forward the case to the SEIAA with the recommendation to grant Environmental Clearance for the expansion in existing steel manufacturing unit having capacity 1,29,600 TPA of MS Billets, 1,26,000 TPA of TMT Rebars/Wire Rod with 30 TPH Induction Furnace, 01 No. of concast and 01 No. of rolling mill to MS Billets @ 3,60,000 TPA and TMT Rebars/wire rods/ MS Strips/ Angles/Channels/ Round/ Flats @ 3,51,000 TPA by addition of 01 No. of Induction Furnace of 30 TPH and 01 of rolling mill at Village Talwara, Mandi Gobindgarh, Tehsil Amluh, District Fatehgarh Sahib, Punjab as per the details mentioned in the application proposal & subsequent presentation /clarifications made by the project proponent and his consultant.

11) The case was considered by the SEIAA in its 289th meeting held on 10.04.2024, wherein SEIAA observed that the case stands recommended by SEAC. The Authority examined and appraised the environmental impacts and other aspects of the project proposal in detail as deliberated upon and recorded in the proceedings of its 289th meeting held on 10.04.2024 and was satisfied with the same. Therefore, the Authority decided to grant Environmental Clearance for the expansion in existing steel manufacturing unit having capacity 1,29,600 TPA of MS Billets, 1,26,000 TPA of TMT Rebars/Wire Rod with 30 TPH Induction Furnace, 01 No. of concast and 01 No. of rolling mill to MS Billets @ 3,60,000 TPA and TMT Rebars/wire rods/ MS Strips/ Angles/Channels/ Round/ Flats @ 3,51,000 TPA by addition of 01 No. of Induction Furnace of 30 TPH and 01 of rolling mill at Village Talwara, Mandi Gobindgarh, Tehsil Amluh, District Fatehgarh Sahib, Punjab as per the details mentioned in Form 2, EIA report and subsequent presentation /clarifications made by the project proponent and his consultant with proposed measures, conditions as proposed by SEAC in addition to the proposed measures.

12) Accordingly, SEIAA, Punjab hereby accords Environmental Clearance to the aforesaid project under the provisions of EIA Notification dated 14.09.2006 and its subsequent amendments subject to proposed measures and strict compliance with terms and conditions as per Annexure-1.

13) The SEIAA reserves the right to stipulate additional conditions if found necessary at subsequent stages and the project proponent shall implement all the said conditions in a time-bound manner. SEIAA may revoke or suspend the environmental clearance if the implementation of any of the above conditions is not found to be satisfactory.

14) Concealing factual data or submission of false/fabricated data and failure to comply with any of the conditions mentioned above may result in withdrawal of this clearance and attract action under the provisions of the Environment (Protection) Act, 1986.

15) Any appeal against this environmental clearance shall lie with the National Green Tribunal, if preferred, within 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.

16) The above conditions will be enforced, inter-alia under the provisions of the Water (Prevention & Control of Pollution) Act, 1974, the Air (Prevention & Control of Pollution) Act, 1981, the Environment (Protection) Act, 1986, the Hazardous Waste (Management, Handling and Transboundary Movement) Rules, 2016, the Public Liability Insurance Act, 1991 read with subsequent amendments therein and any other orders passed by the Hon'ble Supreme

Court of India / High Courts and any other Court of Law relating to the subject matter.

17) This issues with the approval of the Competent Authority.

1. Additional Conditions

1.1	The industry shall submit the progress of developing the green belt in the six-monthly compliance report
1.2	The industry shall install an online monitoring system at the inlet as well as at the outlet of each APCD for monitoring SPM
1.3	The Project proponent shall submit compliance of the action plan proposed to address the public hearing issues along with the six-monthly compliance report of EC condition on Parivesh Portal
1.4	This environmental clearance will be valid for a period of ten years from the date of its issue as per MoEF & CC, GoI notification No. S.O. 1807 (E) dated 12.04.2022 or till the completion of the project, whichever is earlier

1. Statutory Compliance

1.1	The project proponent shall obtain forest clearance under the provisions of the Forest (Conservation) Act, 1986, in case of the diversion of forest land for non-forest purposes involved in the project
1.2	The project proponent shall obtain clearance from the National Board for Wildlife, if applicable
1.3	The project proponent shall prepare a Site-Specific Conservation Plan & Wildlife Management Plan and approved by the Chief Wildlife Warden. The recommendations of the approved Site-Specific Conservation Plan/ Wildlife Management Plan shall be implemented in consultation with the State Forest Department. 2.2	The project proponent shall monitor fugitive emissions in the plant premises at least once every quarter through laboratories recognized under Environment (Protection) Act, 1986 or NABL accredited laboratories
2.3	The project proponent shall install a system to carry out Manual Ambient Air Quality monitoring

The Project Proponent will plant 2,665 saplings (out of which 2,268 sapling have already been planted) of indigenous tree species of at least 8 feet height and healthy growth in 17,750 sqm. permanent green area. The balance plantation activity should be completed within 6 months
7.2	The Project Proponent shall develop a green belt with native tree species (having canopy type structure and especially trees, and not grass) before the completion of the project. The year-wise funds earmarked for environmental protection measures shall be kept in a separate account and will not be diverted for any other purpose.
