No. 849/2A of Thulayanur Village, Thirumayam Taluk, Pudukkottai District, Tamil Nadu by Thiru. G. Elamaran under the provision of the EIA Notification 2006-and as amended thereof.

3. In view of the particulars given in the Para 1 above, the project proposal interalia including Form-2(Part A, B and C)/ Reports were submitted to the SEIAA for an appraisal by the SEIAA under the provision of EIA notification 2006 and its subsequent amendments.
4. The above-mentioned proposal has been considered by SEIAA in the meeting held on 28/05/2024. The minutes of the meeting and all the project documents are available on PARIVESH portal which can be accessed from the PARIVESH portal by scanning the QR Code above.
5. The SEIAA, in its meeting held on 28/05/2024, based on information submitted viz: Form 2 (Part A, B and C), EIA/EMP report etc & clarifications provided by the project proponent and after detailed deliberations on all technical aspects and public hearing issues and compliance thereto furnished by the Project Proponent, recommended the proposal for grant of Environment Clearance under the provision of EIA Notification, 2006 and as amended thereof subject to stipulation of Specific and Standard EC conditions as detailed in the point below.
6. The SEIAA has examined the proposal in accordance with the provisions contained in the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and based on the recommendations of the SEIAA hereby accords Environment Clearance for the instant proposal to M/s. GANESAN ELAMARAN under the provisions of EIA Notification, 2006 and as amended thereof subject to compliance of the Specific and Standard EC conditions as given in Annexure (2)
7. The Ministry/SEIAA reserves the right to stipulate additional conditions, if found necessary.
8. The Environmental Clearance to the aforementioned project is under provisions of EIA Notification, 2006. It does not tantamount to approvals/consent/permissions etc. required to be obtained under any other Act/Rule/regulation. **This Environmental Clearance is accorded for the quantity of 58,625 m<sup>3</sup> of Rough Stone and 10,146 m<sup>3</sup> of Gravel up to the ultimate depth of 27m (2m Gravel + 25m Rough Stone) and the annual peak production should not exceed 22,525 m<sup>3</sup> of Rough Stone and 10,146 m<sup>3</sup> of Gravel.**

**The Environmental Clearance issued is valid as per the approved mine plan period and as per MoEF&CC's notification S.O.1533(E) dated 14.09.2006 and S.O. 1807(E) dated 12.04.2022.**

**11. General Instructions:**

1. The project proponent shall prominently advertise it at least in two local newspapers of the District or State, of which one shall be in the vernacular language within seven days indicating that the project has been accorded environment clearance and the details of SEIAA website where it is displayed.
2. The copies of the environmental clearance shall be submitted by the project proponents to the Heads of local bodies, Panchayats and Municipal Bodies in addition to the relevant offices of the Government who in turn must display the same for 30 days from the date of receipt.
3. The project proponent shall have a well laid down environmental policy duly approved by the Board of Directors (in case of Company) or competent authority, duly prescribing standard operating procedures to have proper checks and balances and to bring into focus any infringements/deviation/violation of the environmental / forest / wildlife norms / conditions.
4. Action plan for implementing EMP and environmental conditions along with responsibility matrix of the project proponent (during construction phase) and authorized entity mandated with compliance of conditions (during operational phase) shall be prepared. The year wise funds earmarked for environmental protection measures shall be kept in separate account and not to be diverted for any other purpose. Six monthly progress of implementation of action plan shall be reported to the Ministry/Regional Office along with the Six-Monthly Compliance Report.
5. Concealing factual data or submission of false/fabricated data may result in revocation of this environmental clearance and attract action under the provisions of Environment (Protection) Act, 1986.
6. The Regional Office of this SEIAA shall monitor compliance of the stipulated conditions. The project authorities should extend full cooperation to the officer (s) of the Regional Office by furnishing the requisite data / information/monitoring reports.
7. Any appeal against this EC shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.

#### 1. Seac Conditions - Site Specific

S. No	EC Conditions
1.1	<ol style="list-style-type: none"><li>1) The PP shall mark the DGPS reference pillars painted with blue &amp; white colour indicating the safety barrier of 7.5 m to be left under the Rule 13 (1) of MCDR, 1988 within the lease boundary and protective bunds, before obtaining the CTO from the TNPCB.</li><li>2) The PP shall <b>register promptly through online in the Shram Suvidha Portal</b> which is the official portal of Ministry of Labour &amp; Employment, Govt of India to obtain <b>Labour Identification Number (LIN) before obtaining the CTO from the TNPCB.</b></li><li>3) The PP shall not employ any external agency for carrying out the blasting operation and he shall also install the temporary magazines approved by the concerned licensing authority before the execution of the lease, for storing the authorized explosives &amp; detonators separately in accordance with the Explosive Rules, 2008.</li><li>4) As accepted by the Project Proponent the CER cost of <b>Rs. 5 Lakhs</b> and the amount shall be spent for the activities as committed towards Government Middle School, Malaikudippatti Village, Thirumayam Taluk, Pudukkottai District, before obtaining CTO from TNPCB.</li><li>5) The PP shall furnish an affidavit indicating the Standard Operating Procedures (SoP) for carrying out the 'Best Mining Practices' in the areas of drilling, blasting excavation, transportation and green belt development, in securing the safety of the persons living within a radial distance of 500 m (danger zone) to the concerned AD (Mines) at the time of lease execution.</li><li>6) <b>Since the structures are situated within a radial distance of 500 m</b>, the PP shall carry out only one blast per day with muffle technique, for not more than 30 to 40 holes in a round, with maximum charge of 375g/hole.</li><li>7) <b>Since the structures are situated within a radial distance of 600 m</b>, the PP shall carry out the scientific studies <b>within a period of six months</b> from the commencement of quarrying operations after obtaining the prior permission from the Director of Mines Safety/Chennai Region, <b>to design the controlled blast parameters</b> including <b>the type of explosive, maximum charge per delay &amp; maximum total charge (kg) per round, maximum number of holes per round</b>, etc along with <b>indicating the statutory competent person responsible for the blasting operation</b>, for reducing the blast-induced ground/air- vibrations and eliminating the fly rock from the blasting operations carried out in the quarry, by involving anyone of these reputed Research and Academic Institution such as CSIR-Central Institute of Mining &amp; Fuel Research / Dhanbad, NIRM/Bangalore, IIT-Madras, NIT-Dept of Mining Engg, Surathkal, and Anna University Chennai-CEG Campus. 	<p>of such scientific study report shall be submitted to the SEIAA, MoEF, TNPCB, AD/Mines-DGM and DMS, Chennai as a part of Environmental Compliance without any deviation.</p> <p>8) The PP shall not carry out the deep hole larger diameter blasting and the secondary blasting of oversize fragments /boulders during the life of the lease period.</p> <p>9) The PP shall only carry out the NONEL-based (or) Electronic Detonator based blasting operation for controlling the environmental impacts with keeping the security guards at a radial distance of 500 m by ensuring that all persons within such area have taken proper shelter.</p> <p>10) In order to check and confirm the formation of benches as stipulated in the Mining Plan duly approved by the AD (Geology &amp; Mines) in accordance with the provisions of MMR 1961 and also to ensure the safety of the persons employed in the quarry, <b>the PP shall carry out the scientific studies after obtaining the prior permission from the Director of Mines Safety/Chennai Region, to assess the slope stability of the existing quarry walls by determining the angle of safety for entire quarry area but ‘zone-wise’ to decide whether the existing slope is safer to work or otherwise to enumerate the requisite feasible mitigation measures if any</b>, during the 4<sup>th</sup> year (or) the depth of quarry reaches 30 m, <b>which will also helpful in designing the proposed benches</b>, by involving any one of the reputed Research and Academic Institutions - CSIR-Central Institute of Mining &amp; Fuel Research / Dhanbad, NIRM/Bangalore, Division of Geotechnical Engineering-IIT-Madras, NIT-Dept of Mining Engg, Surathkal, and Anna University Chennai-CEG Campus. A copy of such scientific study report shall be submitted to the SEIAA, MoEF, TNPCB, AD/Mines-DGM and DMS, Chennai as a part of Environmental Compliance without any deviation.</p> <p>11) As a part of Ground Water Management, the PP shall carry out the scientific studies <b>to assess the existing hydrogeological conditions and impacts of the quarrying operation on the ground water level present in the core zone</b>, within 2 years from the commencement of mining operations, by involving any one of the reputed Research and Academic Institution - CSIR-Central Institute of Mining &amp; Fuel Research / Dhanbad, NIRM/Bangalore, Division of Geotechnical Engineering-IIT-Madras, NIT-Dept of Mining Engg, Surathkal, University of Madras – Centre for Environmental Studies, and Anna University Chennai-Dept of Geology, CEG Campus. A copy of such scientific study report shall be submitted to the SEIAA, MoEF, TNPCB, AD/Mines-DGM and DMS, Chennai as a part of Environmental Compliance without any deviation.</p>

## 2. Air Quality Monitoring And Mitigation Measure

## 3. Water Quality Monitoring And Mitigation Measures


