This is in reference to your application submitted to SEIAA, Odisha vide proposal number SIA/OR/IND2/491518/2024 dated 05/08/2024 for an extension in validity of prior Environmental Clearance (EC) granted vide letter no. 8758/SEIAA dated 19.08.2020 to the project for production of 2.532 KLD country liquor from manufacturing unit of M/s Badakushasthali O.S. Shop At-badakushathali, Tahasil-Kanisi, Dist: Ganjam, State: Odisha of Licensee Sri G. Guru Prasad Reddy under the provision of the EIA Notification 2006-and as amended thereof.

In view of the particulars given in the Para 1 above, the project proposal interalia including Form-6 were submitted to the State Level Expert Appraisal Committee (SEAC) under the provision of Para 9.0 of the EIA notification 2006 and its subsequent amendments. Details in Form 6 can be accessed from the PARIVESH portal by scanning the QR Code above.
4. The brief about the reasons for an extension of validity of EC, as submitted by the Project Proponent in Form-6 and presented during SEAC & SEIAA is annexed to this letter as **Annexure (2)**.
5. The above-mentioned proposal has been considered by SEAC in the meeting held on 20.06.2018. The minutes of the meeting and all the project documents are available on PARIVESH portal which can be accessed by scanning the QR Code above.
6. The SEAC, in its meeting held on 20.06.2018 based on information & clarifications provided by the project proponent and after detailed deliberations recommended the proposal for grant of Environment Clearance with condition that the EC shall be coterminous with the period of new license on the same term & conditions under the provision of EIA Notification, 2006 and as amended thereof.
7. The SEIAA has examined the proposal in its 183rd meeting held on 23.12.2024 in accordance with the provisions contained in the Para 9 of Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and based on the recommendations of SEAC hereby, accords Extension in Validity of Environment Clearance upto validity of excise license period 31.03.2025 and shall be coterminous with the period of new license on the same term & conditions for the instant proposal for production of 2.532 KLD country liquor from manufacturing unit of M/s. Badakushasthali O.S. Shop At- Badakushathali, Tahasil-Kanisi, Dist: Ganjam, State: Odisha of Licensee Sri G. Guru Prasad Reddy under the provisions of EIA Notification, 2006 and as amended thereof subject to compliance of EC conditions, general instructions issued vide EC letter dated and EC letter no. 8548/SEIAA dated 01.07.2020. The term & conditions of EC letter dated 19.08.2020 will remains same.



Annexure 1

Additional EC Conditions

1. This environmental clearance (EC) is valid upto the excise license period i.e. **31.03.2025** and shall be coterminous with the period of validity of the existing Excise License.
2. The proponent shall obtain fresh environmental clearance (EC) if they shift the unit to other location and/or go for higher production capacity.
3. The PP shall implement the EMP with a budgetary allocation as proposed in the EMP report during EC application.
4. The PP shall plant **20 nos. of tree species** like Banyan, Peepal, Neem, Jamun, Mango, Karanj, Arjun etc. as part of tree plantation campaign "**Ek Ped Maa Ke Naam**" and the details of the same shall be uploaded in the MeriLiFE Portal (<https://merilife.nic.in>).
5. The Project Proponent shall uploaded/submitted six monthly EC compliance in the Parivesh Portal of MoEF & CC., Govt. of India only falling which the EC is liable to revoked.



1. Proposal in brief:

- (i) The highlights of the proposal as ascertained from the application and as revealed from proceedings/discussion held during the meeting of SEAC/SEIAA, are given as under.
- (ii) This is a proposal for Extension of validity of environmental clearance for production 2.532 KLD country liquor from manufacturing unit of M/s Badakushasthali O.S. Shop At-badakushathali, Tahasil-Kanisi, Dist: Ganjam, State: Odisha.
- (iii) Documents submitted: Application in Form-6, earlier EC copy, excise license certificate.
- (iv) Environmental Clearance was issued vide letter No -.8758/SEIAA on dated 19.08.2020 validity up to the excise license period. Since then, the EC is being extended after renewal of excise license. Now, the excise license has been renewed. Therefore, the PP has requested you kindly to extend the validity of environmental clearance upto the validity of excise license to obtain the CTO to operate the unit.
- (v) The extension of validity of EC was issued on 10.08.2023 upto the lease period.
- (vi) The excise license no. 04/2019/0007 is valid from 01.04.2024 to 31.07.2024 for the said unit. Further the validity extended from **01.09.2024 to 31.03.2025**.
- (vii) Any deficiencies/omission have been noticed in the above documents- Nil
