SEIAA in its 204th Meeting held on 16/09/2025 perused the case and minutes of the 613rd Meeting of SEAC-1 held on 16/04/2025.

It is noted that original application is for mining of Ordinary Stone (Minor Minerals) capacity – 1,994.85 TPA. After

deliberation, SEIAA unanimously accepted the recommendation of SEAC-1 and decided to grant Environmental Clearance for mining of Ordinary Stone (Minor Minerals) capacity – 1,994.85 TPA in khasra no. 1628, Area – 0.364 Hectare at Village - Gajadharpur, Tehsil - Kusmi, District – Balrampur-Ramanujganj under the EIA Notification, 2006 (as amended) listed in Schedule 1(a) Mining of minerals under Category “B2”.

3. This Environment Clearance is for mining of Ordinary Stone (Minor Minerals) capacity – 1,994.85 TPA in khasra no. 1628, Area – 0.364 Hectare at Village - Gajadharpur, Tehsil - Kusmi, District – Balrampur-Ramanujganj, Chhattisgarh.
4. In view of the particulars given in the Para 1 above, the project proposal interalia including Form-1 (Part A and B) were submitted to the SEIAA under the provision of EIA notification 2006 and its subsequent amendments.
5. The above-mentioned proposal has been considered by State Environment Impact Assessment Authority (SEIAA) in the meeting held on 16/09/2025. The minutes of the meeting and all the Application and documents submitted are available on PARIVESH portal which can be accessed by scanning the QR Code above.
6. Details of the minerals to be mined along with production capacity and the brief on the salient features of the project as submitted by the project proponent in Form 1 (Part A and B) presented are annexed to this EC as Annexure (1).
7. The SEAC, in its meeting held on 16/04/2025, based on information & clarifications provided by the project proponent and after detailed deliberations on all technical aspects and compliance thereto furnished by the Project Proponent, recommended the proposal for grant of Environment Clearance under the provision of EIA Notification, 2006 and as amended thereof subject to stipulation of Specific and Standard EC conditions as detailed in the point below.
8. The SEIAA has examined the proposal in accordance with the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and after accepting the recommendations of the SEAC and hereby decided to grant Environment Clearance for the instant proposal under the provisions of EIA Notification, 2006 and as amended thereof subject to compliance of the Specific and Standard EC conditions as given in Annexure (2).
9. The Ministry reserves the right to stipulate additional conditions, if found necessary.
10. The Environmental Clearance to the aforementioned project is under provisions of EIA Notification, 2006. It does not tantamount to approvals/consent/permissions etc. required to be obtained under any other Act/Rule/regulation. The Project Proponent is under obligation to obtain approvals /clearances under any other Acts/ Regulations or Statutes, as applicable, to the project.
11. The PP is under obligation to implement commitments made in the Environment Management Plan, which forms part of this EC.

Project Proponent shall plant the saplings in the restored area as per the condition of the previous EC.</li> <li>3. Compliance of the completion of the above conditions is mandatory. If these conditions are not complied within 3 months, the concerned RO, CECB shall take necessary steps to stop the mining operations and resumption of the mining operations will be subject to the fulfilling of above conditions.</li> <li>4. 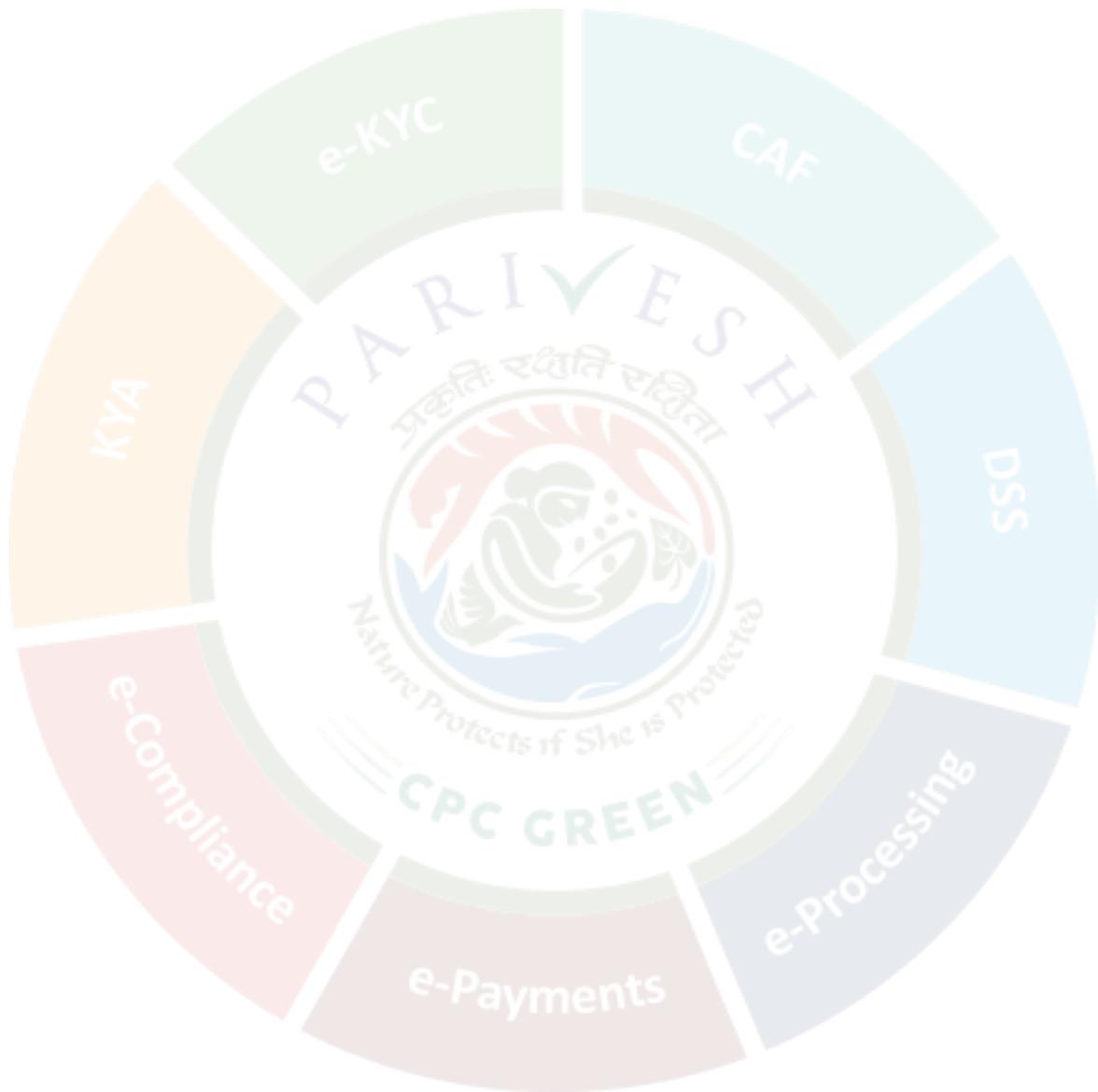


