Sir/Madam,

This is in reference to your application submitted to SEIAA vide proposal number SIA/CG/MIN/502313/2024 dated 21/10/2024 for grant of prior Environmental Clearance (EC) to the project under the provision of the EIA Notification 2006-and as amended thereof.

3. This Environment Clearance is for for mining of Dolomite capacity – 70,000 TPA (maximum production quantity as per mining plan) in Kharsa No. 875 (part), area - 2.72 Ha. of Village - Dhaurabhata, Tehsil - Bilha, District – Bilaspur Chhattisgarh.

4. In view of the particulars given in the Para 1 above, the project proposal interalia including Form-2(Part A, B and C)/ EIA & EMP Reports were submitted to the SEIAA for an appraisal by the SEIAA under the provision of EIA notification 2006 and its subsequent amendments.
5. The above-mentioned proposal has been considered by SEIAA in the meeting held on 24/04/2025. The minutes of the meeting and all the project documents are available on PARIVESH portal which can be accessed from the PARIVESH portal by scanning the QR Code above. Brief description of the project is as under:
6. Details of the minerals to be mined along with production capacity and the brief on the salient features of the project as submitted by the project proponent in Form 1 (Part A and B) in the reports and as presented during SEIAA are annexed to this EC as Annexure (1).
7. The SEIAA, in its meeting held on 24/04/2025, based on information submitted viz: Form 1 (Part A, B and C), EIA/EMP report etc & clarifications provided by the project proponent and after detailed deliberations on all technical aspects and public hearing issues and compliance thereto furnished by the Project Proponent, recommended the proposal for grant of Environment Clearance under the provision of EIA Notification, 2006 and as amended thereof subject to stipulation of Specific and Standard EC conditions as detailed in the point below.
8. The SEIAA has examined the proposal in accordance with the provisions contained in the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and based on the recommendations of the SEIAA hereby accords Environment Clearance for the instant proposal to M/s. HARISH SHAH under the provisions of EIA Notification, 2006 and as amended thereof subject to compliance of the Specific and Standard EC conditions as given in Annexure (2)
9. The Ministry reserves the right to stipulate additional conditions, if found necessary.
10. The Environmental Clearance to the aforementioned project is under provisions of EIA Notification, 2006. It does not tantamount to approvals/consent/permissions etc. required to be obtained under any other Act/Rule/regulation. The Project Proponent is under obligation to obtain approvals /clearances under any other Acts/ Regulations or Statutes, as applicable, to the project.
11. The PP is under obligation to implement commitments made in the Environment Management Plan, which forms part of this EC.
12. General Instructions:
 1. The project proponent shall prominently advertise it at least in two local newspapers of the District or State, of which one shall be in the vernacular language within seven days indicating that the project has been accorded environment clearance and the details of SEIAA website where it is displayed.
 2. The copies of the environmental clearance shall be submitted by the project proponents to the Heads of local bodies, Panchayats and Municipal Bodies in addition to the relevant offices of the Government who in turn must display the same for 30 days from the date of receipt.
 3. The project proponent shall have a well laid down environmental policy duly approved by the Board of Directors (in case of Company) or competent authority, duly prescribing standard operating procedures to have proper checks and balances and to bring into focus any infringements/deviation/violation of the environmental / forest / wildlife norms / conditions.
 4. Action plan for implementing EMP and environmental conditions along with responsibility matrix of the project proponent (during construction phase) and authorized entity mandated with compliance of conditions (during operational phase) shall be prepared. The year wise funds earmarked for environmental protection measures shall be kept in separate account and not to be diverted for any other purpose. Six monthly progress of implementation of action plan shall be reported to the Ministry/Regional Office along with the Six-Monthly Compliance Report.
 5. Concealing factual data or submission of false/fabricated data may result in revocation of this environmental clearance and attract action under the provisions of Environment (Protection) Act, 1986.
 6. The Regional Office of this SEIAA shall monitor compliance of the stipulated conditions. The project

authorities should extend full cooperation to the officer (s) of the Regional Office by furnishing the requisite data / information/monitoring reports.

7. Any appeal against this EC shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.

1. Specific Condition

1.1	<ol style="list-style-type: none"> Chhattisgarh Environment Conservation Board (CECB) shall ensure that CTO/Renewal shall be issued only after the restoration of the excavated 7.5 meter wide safety green belt area as envisioned in the restoration plan. PP shall submit the compliance report for plantation over entire safety zone area along with geotag photography and drone survey photography within one year of grant of EC date. Mine Working Depth to be restricted so as not to intersect the ground water table.
1.2	<p>Additional Conditions:</p> <ol style="list-style-type: none"> Project proponent shall ensure the erection of boundary pillars as per provisions of Minor minerals Rules 2015, and shall also do fencing all along the mining boundary. The Project proponent shall do plantation over entire safety zone for developing green belt with healthy species which has fast growth and has good canopy cover to serve as barrier for propagation of pollutants from mine area.

The desilting of silting ponds should be done regularly. 12. Adequate sanitation, waste management system should be developed including construction of soak pits and safety tanks. 13. The PP shall ensure to install the measuring instrument for consumption of water and maintain logbook for it. 14. The PP shall make arrangement for energy conservation and promote the use of non-conventional energy like solar lights. 15. Personal protective equipment like dust mask, ear plug should be issued to workers who are exposed to dust and noise pollution beyond it's permissible limit. 16. In case of part of cluster mines, The PP shall contribute his share in executing the common EMP. 17. The CER Plan should be implemented within one year and it should be operated and maintained till the mine closure plan is implemented. 18. Employment to the local people should be provided under the Chhattisgarh Model Rehabilitation Policy. 19. To restore the excavated 7.5-meter-wide safety green belt area shall be completed within one year as per the plan submitted. <p>Mine closure plan</p> <ol style="list-style-type: none"> 1. Ambient air quality monitoring shall be conducted once in a year in the core zone as well as in the buffer zone for monitoring of pollutants, namely particulates, SO₂ and NO_x. Location of the stations shall be decided based on the meteorological data, topographical features and environmentally and ecologically sensitive receptors. The report shall be submitted to the SEIAA, C.G./ SEAC, C.G. 2. The Ambient Air Quality monitoring in the core zone shall be carried out. Data on ambient air quality and heavy metals such as Hg, As, Ni, Cd, Cr and other monitoring data shall be regularly reported to the Ministry/Regional Office and to the CPCB/SPCB. 3. 
