

Sir,

Whereas, your case for grant of prior Environmental Clearance (EC) was placed before JKEAC for appraisal in its 151<sup>st</sup> meeting held on 18-02-2025.

Whereas, during appraisal JKEAC examined the Mining Block using Google Earth and photographs provided by the Consultant, wherein evidence of illegal mining activities and material dumping within and around the block was observed, resulting in the complete depletion of mineral resources.

Whereas, on JKEAC upon examining the C-Section of the block, observed that there is a 10-meter drop form the side of the AGFE pillars, and no material can be extracted from the site, the site requires anti-erosion measures for slop stabilization and as a result, mining operation in the area were deemed unfeasible.

Whereas, it was also observed by the Committee that the Forest Deptt. has not granted the required NOC for the project, listing it as Gair Mumkin Jhad, restricting its approval.


Whereas, the JKEAC after due deliberation recommended the rejection of EC for the said mining block.

Whereas, the JKEIAA in its 109<sup>th</sup> meeting held on 07-04-2025 upheld the recommendation of the JKEAC and rejected the case of grant of prior EC.

Now therefore, it is to intimate that your case for grant of prior EC has been rejected.
