1. In view of the particulars given in the Para 1 above, the project proposal interalia including Form-1(C)/ EIA & EMP Reports were submitted to the Ministry for an appraisal by the SEIAA under the provision of EIA notification 2006 and its subsequent amendments.

2. The above-mentioned proposal has been considered by SEIAA in the meeting held on 27/01/2025. The minutes of the meeting and all the application and documents submitted [(viz. Form-1 Part A, Part B, Part C EIA, EMP)] are available

on PARIVESH portal which can be accessed by scanning the QR Code above.

3. The SEAC, in its meeting held on 20.11.2024, based on the submission & presentation made by the project proponent (PP), observed that the plot area for the proposed project as per the geo-coordinates mentioned in the PFR uploaded by the PP falls outside the potential mining zone recorded in the approved District Survey Report (DSR) of Birbhum district. Considering the above, the SEAC recommended the proposal for Rejection of Environment Clearance and forwarded to SEIAA for rejection.
4. The SEIAA, in its meeting held on 27.01.2024, has examined the proposal in accordance with the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and after accepting the recommendations of the State Expert Appraisal Committee hereby decided to Reject Environment Clearance for instant proposal of M/s. IZHAR KHAN under the provisions of EIA Notification, 2006 and as amended thereof. It is to be noted that due to technical issues in Parivesh Portal there was a delay in accessing this proposal.
5. **The Application for EC is REJECTED.**
