

Sir/Madam,

This has reference to your online application no. SIA/OR/MIN/464228/2024 dated 06.03.2024, wherein you have requested for amendment (i.e. amendment of EC regard to annual production of sand as per replenishment study report) of Environmental Clearance (EC) granted by SEIAA, Odisha vide letter no./EC Identification No. EC22B001OR123629 dt. 22.07.2022 in favour of Sri Jani Venkate Rao, the lessee/successful bidder.

2. The application was examined in the State Environment Impact Assessment Authority (SEIAA), Odisha in its 164th meeting held on 23.04.2024 & 25.04.2024 in accordance with the EIA Notification, 2006 as amended from time to time and the following points are noted;

- (i) This is a proposal for amendment of EC Gunupur Sand Bed - I over an area of 15.00 Acres Or 6.070 Hectares having Khata No. - 330 and Plot No.- 522 in Village Gunupur, Tahasil Gunupur, District Rayagada, State Odisha.
- (ii) The project proponent has obtained EC from SEIAA, Odisha vide EC letter no. EC Identification No. – EC22B001OR123629 dt. 22.07.2022 and EC amended vide letter no. 5324/SEIAA dt. 02.09.2022 for Gunupur Sand Bed - I over an area of 15.00 Acres Or 6.070 Hectares having Khata No. - 330 and Plot No.- 522 in Village Gunupur, Tahasil Gunupur, District Rayagada, State Odisha.
- (iii) During EC application the PP has submitted required documents along with mining plan where it is mentioned that mineable reserve of the proposed sand was 52113 cum with depth of sand deposition was 1.0 meter and proposed for annual extraction-15050 cum.
- (iv) The SEIAA allowed the production quantity of sand 5000 cum for the 1st year lease period with depth of mining 0.5 meter.
- (v) There is an EC conditions point no. 7.1 to 7.2 in page no. 03 that "Pending carrying out of the study & submission of the report, this clearance is being granted in an adhoc manner and is liable to be revoked

- after one year i.e. after November 2023, if satisfactory replenishment study report is not submitted.”
- (vi) The transfer of EC issued by SEIAA, Odisha vide letter no.5098/SEIAA dt. 12.08.2022 for this project with same conditions of EC issued earlier.
 - (vii) The PP has extracted 5000 cum of sand for the period 2022-23
 - (viii) The replenishment study was done by Geocon Surveys Pvt. Ltd., the ORSAC empanel agency with mentioned that the Pre-Monsoon Standard Elevation (SE1) is 82.07m and Post-Monsoon Standard Elevation (SE2) is 82.78m and quantity of sand replenished is 10395 cum and proposed production is 10500 cum/annum.
 - (ix) Documents submitted for amendment of EC;
 - a. Form No. 4 for amendment of Environmental Clearance,
 - b. Replenishment study report
3. The proposal was placed in SEAC meeting held on 21.03.2024 and the SEAC recommended the following: Replenishment study pre-monsoon carried out in June and post monsoon in January by ORSAC empaneled agency. Page 19 of 30 The replenishment study was found to be correct. Out of total Lease area, the sand bearing mineable zone area is 146 41 sqmt. Replenished thickness is 1.2 Mt. It is coming to be 17569 cum, out of which PP proposed for 10500 cum which may be recommended.
4. Amendment of Environmental Clearance (EC) letter no./Identification no. EC22B001OR123629 dt. 22.07.2022 issued for Gunupur River Sand Quarry-I in favour of Sri Jani Venkate Rao is **allowed** for extraction quantity of sand **10500 cum/annum** for rest of the lease period i.e. for 2nd year, 3rd year, 4th year and 5th year. The other stipulated terms and conditions of the original EC initially granted remains same subject to satisfactory compliance to all the stipulated terms and conditions of EC along with following additional stipulation:

Additional stipulation

- (i) The PP is required to carry out the Annual rate of replenishment study (ARRS) through ORSAC empanel agency in subsequent year and submit the report to SEIAA, Odisha.
- (ii) The validity of EC is for validity of DSR or validity of lease period whichever is earlier.
- (iii) The Project Proponent (lease holder) shall deposit Rs.3,00,000/- with the respective District Environment Society for raising 600 plants (minimum @100 trees per Ha) of native species within 2 years in a suitable location adjoining to quarry
- (iv) The PP will implement the EMP with a budgetary allocation as proposed in the EMP report during EC application.

The Project Proponent shall uploaded/submitted six monthly EC compliance in the Parivesh Portal of MoEF & CC., Govt. of India only within six months (06) from date of issue of transfer of EC, falling which the EC is liable to revoked.
