Based on the recommendations of the State Expert Appraisal Committee, Odisha (SEAC, Odisha), information & clarifications provided by the project proponent and after detailed deliberations the authority decided "Since, the increasing production is more than 50% of earlier EC, the case can not be considered under amendment of EC category. Hence, the authority decided to reject the amendment of with an

instruction to the PP to apply afresh in Form-2 for fresh consideration for EC for Expansion.”

3. Hence, the proposal is Rejected as per provision of EIA Notification, 2006 and as amended thereof.
