Amendment in EC- Form-4 were submitted to the SEAC, Odisha for an appraisal by the State Expert Appraisal
Committee (SEAC) under the provision of EIA notification 2006 and its subsequent amendments.

2. The above-mentioned proposal has been considered in 175th Meeting of State Environment Impact Assessment

Authority meeting held from 23/10/2024 to 24/10/2024. Based on the recommendations of the State Expert Appraisal Committee, Odisha (SEAC, Odisha), information & clarifications provided by the project proponent and after detailed deliberations the Authority decided “ After detailed deliberation, the authority accepted the recommendation of SEAC and rejected the amendment of EC application as the ARRS report is not acceptable due to the following reasons:-

- i) Most part remained waterlogged even in post monsoon.
- ii) The quantity available in the non-water logged safe area is required to be calculated properly.
- iii) The water course is flowing in middle of lease area.
- iv) No GCPs are taken. v) No error statement is given. ”

Therefore, the proposal for Amendment in EC is Rejected as per provision of EIA Notification, 2006 and as amended thereof.
