1. In view of the particulars given in the Para 1 above, the project proposal interalia including Form-1(C)/ EIA & EMP
Reports were submitted to the Ministry for an appraisal by the Expert Appraisal Committee (SEIAA) in the Ministry
under the provision of EIA notification 2006 and its subsequent amendments.

2. The above-mentioned proposal has been considered by Expert Appraisal Committee of in the meeting held on 23/07/2024. 3. The brief about configuration of plant/equipment, products and byproducts and salient features of the project along with environment settings, as submitted by the Project proponent in Form-1 (C)/EIA & EMP Reports/presented during are annexed to this EC as Annexure (1) and Annexure (2).

The SEIAA, in its meeting held on 23/07/2024, based on information & clarifications provided by the project proponent and after detailed deliberations recommended the proposal for Rejection of Environment Clearance under the provision of EIA Notification, 2006 and as amended thereof subject to stipulation of specific and general conditions as detailed in the point below.
5. The MoEF&CC has examined the proposal in accordance with the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and after accepting the recommendations of the Expert Appraisal Committee hereby decided to Reject Environment Clearance for instant proposal of M/s. KAMLESH BADWANI under the provisions of EIA Notification, 2006 and as amended thereof.
6. As per the Hon'ble NGT order dated 13.09.2018 of para 22 "a cluster or an individual lease size exceeds 5 ha the EIA/EMP be made applicable in the process of grant of prior environment clearance." Project proponent needs to apply in Parivesh Portall under TOR application) and decided to reject/ return the present proposal and suggested to the project proponent to apply the fresh TOR application in the Parivesh Portal as per the notification and office memorandum issued by MoEF&CC from time to time.
