1. In view of the particulars given in the Para 1 above, the project proposal interalia including Application for Amendment in EC- Form-4 were submitted to the SEAC, Odisha for an appraisal by the State Expert Appraisal Committee (SEAC) under the provision of EIA notification 2006 and its subsequent amendments.

2. The above-mentioned proposal has been considered in 175th Meeting of State Environment Impact Assessment Authority meeting held from 23/10/2024 to 24/10/2024. Based on the recommendations of the State Expert Appraisal

Committee, Odisha (SEAC, Odisha), information & clarifications provided by the project proponent and after detailed deliberations the Authority decided “ Considering all the above facts with detailed deliberation, the authority rejected the amendment of EC application as the ARRS report is not acceptable due to the following reasons:

1) No document supporting replenishment study report based on pre and post monsoon surveys carried out by competent agencies by 31st December 2022 as per the transfer EC grant order could be found. In the compliance report lessee has only referred to the current replenishment study 2023 report.

2) The Mining Plan needs to be revised and approved by the competent authority after vetting the findings reported in the ARRS report such as reported abnormal riverbed sand surface elevation changes and their abnormal differences during post monsoon keeping in view the differences regarding quarry floor level and surface elevations mentioned in the approved mining plan. ”

Therefore, the proposal for Amendment in EC is Rejected as per provision of EIA Notification, 2006 and as amended thereof.
