1. In view of the particulars given in the Para 1 above, the project proposal interalia including Form-1(Part A and B) were submitted to the Ministry for an appraisal by the State Environment Impact Assessment Authority(SEIAA) and Appraisal Committee (SEAC) in the Ministry under the provision of EIA notification 2006 and its subsequent amendments.

The State Level Expert Appraisal Committee (SEAC) examined the proposal in its meeting held on **07.12.2024 & 06.03.2025** and based on the information furnished by the proponent, the presentation made by the Environmental Co-ordinator of **M/s. EHS 360 labs private limited, Hyderabad**, the committee recommended not to consider for EC under the provision of EIA Notification, 2006 and as amended thereof.

The minutes of the meeting and all the Application and documents submitted [(viz. Form-1 Part A, Part B, Part C EIA, EMP)] are available on PARIVESH portal which can be accessed by scanning the QR Code above.

The SEIAA has examined the proposal in its meeting held on **25.03.2025** in detail the recommendations of SEAC and the EE, I&CAD dept., Irrigation Division, Mahabubabad letter dt: 27.10.2016, noted that the proposed site is located within the water body as per the KML file submitted by the proponent. As per the ADMG, Mahabubabad there is no excavation/production during the period 2018-19 to 2024-25 (upto 20.06.2024). Hence, rejected the project for Environmental Clearance for instant proposal of **M/s. Sri Sai Ram Black Granites** under the provision of EIA Notification, 2006 and as amended thereof and with stipulation of specific and general conditions as detailed in Annexure (1).

No mining activity shall be carried out without obtaining prior Environmental Clearance as per the provisions laid under EIA Notification, 2006 and its amendments thereof.
