



- I. The SEIAA, AP vide reference 1st cited issued EC order to the 2.37 Ha Road Metal & Building Stone of Sri. K. Narasimha Rao at Sy.No.71 of Kongavanipalem (V), Bhogapuram (M), Vizayanagaram District, A.P. for mining of Road Metal & Building Stone - 94,800 m³/Annum.
- II. Smt K.Padma, vide reference 3rd cited requested for Transfer of EC from Sri K.Narasimha Rao to Smt K.Padma,
- III. The District Mines and Geology officer, Vizianagaram, vide Procd. No. 4569/Q/2005, dt. 06.04.2024 declared the name of Smt K.Padma as successor lessee of Sri K.Narasimha Rao.
- IV. Legal heirs of Sri K.Narasimha Rao submitted the NOC affidavit through online on 03.06.2024 for transfer of EC.
- V. The above issue was examined by the State Level Environment Impact Assessment Authority (SEIAA) meeting held on 20.12.2024, and decided to transfer Environmental Clearance from Sri K. Narasimha Rao to Smt K. Padma subject to submission of Undertaking by the transferee on Rs.100/- Non-judicial stamp paper in the prescribed format enclosed.
- VI. Accordingly, the SEIAA raised ADS on 07.01.2025 and the proponent submitted the Undertaking by the transferee on Rs.100/- Non-judicial stamp paper on 07.01.2025.
- VII. The SEIAA, A.P., hereby transfers the Environmental Clearance in the

name of Smt K. Padma all other terms and conditions stipulated in the EC order issued vide reference 1st cited shall remains the same.
