

- I. The SEIAA, AP vide reference 1<sup>st</sup> cited issued EC order to the 0.3 Ha Road Metal & Building Stone of Sri K. Narasimha Rao, at Sy.No.282/47, Munjeru (V), Bhogapuram (M), Ananthapuram District, A.P. Mining of Road Metal & Building Stone – 13200 m<sup>3</sup>/annum.
- II. Smt. Kotapati Padma, vide reference 3<sup>rd</sup> cited requested for Transfer of EC from Sri K.Narasimha Rao to Smt. Kotapati Padma,
- III. The District Mines & Geology, Vizianagaram vide Procd. No. 1354/Q/2014, dt.06.04.2024 has transferred the mine lease from Sri K.Narasimha Rao to Smt. Kotapati Padma.
- IV. Legal heirs of Sri K.Narasimha Rao submitted the NOC affidavit through online on 03.06.2024 for transfer of EC.
- V. The issue was examined by the State Level Environment Impact Assessment Authority (SEIAA) meeting held on **20.12.2024**, and decided to transfer Environmental Clearance from Sri K.Narasimha Rao to Smt. Kotapati Padma subject to submission of Undertaking by the transferee on Rs.100/- Non-judicial stamp paper in the prescribed format enclosed.
- VI. The applicant Smt K.Padma submitted copy of the Undertaking affidavit through online on 07.01.2025.
- VII. Accordingly, the SEIAA raised ADS on 07.01.2025 and the proponent

submitted the Undertaking by the transferee on Rs.100/- Non-judicial stamp paper on 07.01.2025.

- VIII. The SEIAA, AP. is hereby transfers the Environmental Clearance in the name of Smt. Kotapati Padma with all terms and conditions stipulated in the EC order vide reference 1<sup>st</sup> cited remain the same.
