1. In view of the particulars given above, the project proposal interalia including Application for Amendment in EC-Form-4 were submitted to the SEAC, Odisha for an appraisal by the State Expert Appraisal Committee (SEAC) under the provision of EIA notification 2006 and its subsequent amendments.

2. The above-mentioned proposal was considered in the 177th Meeting of State Environment Impact Assessment

Authority meeting held from 29/10/2024. Based on the recommendations of the State Expert Appraisal Committee, Odisha (SEAC, Odisha), information & clarifications provided by the project proponent and after detailed deliberations the Authority decided “After detailed deliberations, the authority rejected the amendment of EC application since the proposed enhancement of stone is from 2560 cum to 6000 cum which is more than 50% of the original EC granted. As per OM No.IA3- 22/10/2022-IA.III dated 11.04.2022 of Ministry, the PP is required to apply the proposal as an expansion proposal in the Common Application for EC for Minor Minerals of mine lease (0 to 5Ha) in Form-2.”

Therefore, the proposal for Amendment in EC is Rejected as per provision of EIA Notification, 2006 and as amended thereof.
