This is in reference to your application submitted to Ministry vide proposal number SIA/OR/MIN/491418/2024 dated null for Rejection of prior Environmental Clearance (EC) to the project under the provision of the EIA Notification 2006-and as amended thereof.

1. In view of the particulars given in the Para 1 above, the project proposal interalia including Application for Amendment in EC- Form-4 were submitted to the SEAC, Odisha for an appraisal by the State Expert Appraisal Committee (SEAC) under the provision of EIA notification 2006 and its subsequent amendments.

2. The above-mentioned proposal has been considered in 175th Meeting of State Environment Impact Assessment

Authority meeting held from 23/10/2024 to 24/10/2024. Based on the recommendations of the State Expert Appraisal Committee, Odisha (SEAC, Odisha), information & clarifications provided by the project proponent and after detailed deliberations the Authority decided “.

After detailed deliberation, the authority accepted the recommendation of SEAC and rejected the amendment of EC application as the ARRS report is not acceptable due to the following reason:

1) There is no detailed calculation of pre-monsoon and post-monsoon workable area. In the ARRS report it is mentioned as below: “Since the most of lease area was water logged during post monsoon survey as compared to pre-monsoon survey, Drone survey could not be conducted in water logged area. So, it is estimated that total area 39486.040 m² for Hirapur Sand Bed is considered as post-monsoon safe workable area” This post monsoon safe workable area has been taken as common safe workable area which is 78.96% of total lease area.

2)The KML file (20.04.2024) shows that there is water flow (about 15%) inside lease area. Detail calculation of CSA is required excluding water-logged area and other requirements as per latest guidelines.

Therefore, the proposal for Amendment in EC is Rejected as per provision of EIA Notification, 2006 and as amended thereof.
