2. The above-mentioned proposal was considered in the 175th Meeting of State Environment Impact Assessment Authority meeting held from 24/10/2024. Based on the recommendations of the State Expert Appraisal Committee,

Odisha (SEAC, Odisha), information & clarifications provided by the project proponent and after detailed deliberations the Authority decided “After detailed deliberation, the authority rejected the proposal of EC as per NGT Order dated 13.09.2018 passed in OA No-186 of 2016 (Satendra Pandey Vs MoEF & CC & Anr.) and OM dated 12.12.2018 issued by the MoEF&CC. The PP shall apply the proposal as Category B1 taking the cluster approach as the total lease area under the cluster is more than 5ha.”

Therefore, the proposal for EC is Rejected as per provision of EIA Notification, 2006 and as amended thereof.
