1. In view of the particulars given in the Para 1 above, the project proposal inter alia including Application for Amendment in EC- Form-4 were submitted to the SEAC, Odisha for an appraisal by the State Expert Appraisal Committee (SEAC) under the provision of EIA notification 2006 and its subsequent amendments.

2. The above-mentioned proposal has been considered by the State Environmental Impact Assessment Authority, Odisha (SEIAA, Odisha) in 171st meeting held on 11/07/2024 to 12/07/2024. Based on the recommendations of the State Expert Appraisal Committee, Odisha (SEAC, Odisha), information & clarifications provided by the project proponent and after detailed deliberations the Authority decided "The Authority agreed with the recommendation of SEAC and decided to reject the amendment of EC proposal as replenishment study report submitted by the PP is not accepted by SEAC due to the following reasons:

Replenishment Study is defective as below-

- i) No GCPs are given.
 - ii) How Drone data of water-logged parts of sections is calculated is not clear.
 - iii) Common safe workable area is not worked out correctly.
 - iv) Erosion and deposition areas are not worked out separately. Rather an average figure is taken uniformly.
 - v) Calculations of volume etc. are erroneous.
 - vi) Why this replenished volume is extended to three years period is not understandable.
- Hence, Replenishment Study report is not acceptable".

Therefore, the proposal for Amendment in EC is Rejected as per provision of EIA Notification, 2006 and as amended thereof.
