In view of the particulars given in the Para 1 above, the project proposal interalia including Form-1(Part A and B) were submitted to the Ministry for an appraisal by the State Environment Impact Assessment Authority(SEIAA) and Appraisal Committee (SEAC) in the Ministry under the provision of EIA notification 2006 and its subsequent amendments.

The State Level Expert Appraisal Committee (SEAC) examined the proposal in its meeting held on 27.09.2024 and based on the information furnished by the proponent, the presentation made by the Environmental Co-ordinator of M/s. Ampl

Environ Pvt. Ltd., Hyderabad, the committee recommended the proposal for grant of EC under the provision of EIA Notification, 2006 and as amended thereof.

The minutes of the meeting and all the Application and documents submitted [(viz. Form-1 Part A, Part B, Part C EIA, EMP)] are available on PARIVESH portal which can be accessed by scanning the QR Code above.

The SEIAA has examined the proposal in its meetings held on 11.11.2024 and after accepting the recommendations of the State Level Expert Appraisal Committee (SEAC), hereby decided to grant EC for instant proposal of M/s. Aruna Stone Crusher under the provision of EIA Notification, 2006 and as amended thereof and with stipulation of specific and general conditions as detailed in Annexure (1).

The Ministry reserves the right to stipulate additional conditions, if found necessary.

The EC to the aforementioned project is under provisions of EIA Notification, 2006. It does not tantamount to approvals/consent/permissions etc. required to be obtained under any other Act/Rule/regulation. The Project Proponent is under obligation to obtain approvals /clearances under any other Acts/ Regulations or Statutes, as applicable, to the project

### 3. General Instructions:

1. The project proponent shall prominently advertise it at least in two local newspapers of the District or State, of which one shall be in the vernacular language within seven days indicating that the project has been accorded environment clearance and the details of SEIAA website where it is displayed.
2. The copies of the environmental clearance shall be submitted by the project proponents to the Heads of local bodies, Panchayats and Municipal Bodies in addition to the relevant offices of the Government who in turn must display the same for 30 days from the date of receipt.
3. The project proponent shall have a well laid down environmental policy duly approved by the Board of Directors (in case of Company) or competent authority, duly prescribing standard operating procedures to have proper checks and balances and to bring into focus any infringements/deviation/violation of the environmental / forest / wildlife norms / conditions.
4. Action plan for implementing EMP and environmental conditions along with responsibility matrix of the project proponent (during construction phase) and authorized entity mandated with compliance of conditions (during operational phase) shall be prepared. The year wise funds earmarked for environmental protection measures shall be kept in separate account and not to be diverted for any other purpose. Six monthly progress of implementation of action plan shall be reported to the Ministry/Regional Office along with the Six-Monthly Compliance Report.
5. Concealing factual data or submission of false/fabricated data may result in revocation of this environmental clearance and attract action under the provisions of Environment (Protection) Act, 1986.
6. The Regional Office of this SEIAA shall monitor compliance of the stipulated conditions. The project authorities should extend full cooperation to the officer (s) of the Regional Office by furnishing the requisite data / information/monitoring reports.
7. Any appeal against this EC shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.

Initially quarry lease was granted to Sri. G. Nageshwara Rao by DDM&G, Hyderabad vide Procds dt: 24.06.2000 for a period of 10 years. Subsequently the quarry lease was executed with the ADM&G Medak vide Procds. dt: 28.06.2000 for a period of 10 years and is valid upto 27.06.2010. Further, the quarry lease was transferred to Sri. Md. Zameer by the DDM&G, Nizamabad vide Procds. dt: 10.04.2002 for the un-expired portion of quarry lease period upto 27.06.2010 and the same was executed by the ADM&G, Medak vide Procds dt: 08.05.2002. 1st renewal of quarry lease was granted by DDM&G, Hyderabad for a period of 15 years vide Procds. dt: 17.12.2015. Execution of lease was granted by ADM&G, Medak vide Procds. dt: 23.12.2015 for the lease period valid upto 27.06.2025. Scrutinized/Approved Mining Plan lr. dt: 07.09.2022; Lr.dt.23.04.2022 of ADM&G, Sangareddy District informing that there are 8 existing quarry leases falling within 500m from the proposed quarry lease. However, the present mine lease area is 1.10 Ha., is less than 5.0 Ha., and was granted before 09.09.2013. Hence, cluster notification is not applicable to the mine.

ADM&G, Sangareddy district vide lr. dt: 03.07.2024 furnished dispatch particulars during the period from 2000-01 to 2023-24. As per the details the dispatch permits were carried out during the period from 2001-02 to 2010-11; 2015-16 to 2019-20 & from 2021-22 to 2023-24 and Nil during the remaining period.

The total cost of the project is Rs. 50.0 lakhs. The proponent is proposing budget for environmental protection with capital cost of Rs. 9.10 lakhs and recurring cost of Rs. 5.40 lakhs/annum
