4. The Authority observed that as per the revised mining plan approved by Department of Industries vide No. Udyog-Bhu(Khani-4)Laghu-137/97-vol-II 1658 dated 10/6/2024 the mining area has been changed from 18-96-73 to 10-69-69 Hectares.

The SEIAA, in its meeting held on 30/09/2024 , based on information & clarifications provided by the project proponent and after detailed deliberations recommended the proposal for Rejection of Environment Clearance under the provision of EIA Notification, 2006 and as amended thereof subject to stipulation of specific and general conditions as detailed in the point below.

The MoEF&CC has examined the proposal in accordance with the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and after accepting the recommendations of the Expert Appraisal Committee hereby decided to Reject Environment Clearance for instant proposal of M/s. Harsaran Singh Maini under the provisions of EIA Notification, 2006 and as amended thereof.
