**Subject:** Extension in validity of prior Environmental Clearance (EC) Identification no. EC23B001OR181870 dated 17.01.2023 granted to the project of Padampuri Stone Quarry-III to Sri Piyush Jain, the successful bidder/lessee under the provision of the EIA Notification 2006 and as amended thereof regarding.

**Sir/Madam,**

This is in reference to your application submitted to SEIAA, Odisha vide proposal number SIA/OR/MIN/516366/2024 dated 27/12/2024 for an extension in validity of prior Environmental Clearance (EC) granted to the project of Padampuri Stone Quarry-III about an area of 1.214 Ha. over plot no- 227 & Khata No- 76 at village- Padampuri, Tahasil / District- Nuapada, Odisha to Sri Piyush Jain, the successful bidder/lessee under the provision of the EIA Notification 2006-and as amended thereof.

3. In view of the particulars given in the Para 1 above, the project proposal interalia including Form-6 were submitted to the SEIAA, Odisha for appraisal of State Level Expert Appraisal Committee (SEAC) under the provision of Para 9.0 of the EIA notification 2006 and its subsequent amendments. Details in Form-6 can be accessed from the PARIVESH portal by scanning the QR Code above.
4. The brief about the reasons for an extension of validity of EC, as submitted by the Project Proponent in Form-6 and presented during SEAC is annexed to this letter as Annexure (2).
5. The above-mentioned proposal has been considered by the State Level Expert Appraisal Committee (SEAC) in the meeting held on 12.02.2025. The minutes of the meeting and all the project documents are available on the PARIVESH portal which can be accessed by scanning the QR Code above.
6. The SEAC, in its meeting held on 12.02.2025 based on information & clarifications provided by the project proponent and after detailed deliberations, the SEAC recommended the proposal for extension in validity in Environment Clearance for the remaining period of lease under the provision of EIA Notification, 2006 and as amended thereof.
7. The SEIAA, Odisha has examined the proposal in 192<sup>nd</sup> meeting held on 20.03.2025 in accordance with the provisions contained in the Para 9 of Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and based on the recommendations of the SEAC and hereby accords Extension in Validity of Environment Clearance Identification no. EC23B001OR181870 dated 17.01.2023 for the instant proposal of of Padampuri Stone Quarry-III about an area of 1.214 Ha. over plot no- 227 & Khata No- 76 at village- Padampuri, Tahasil / District- Nuapada, Odisha to Sri Piyush Jain, the successful bidder/lessee is allowed for the remaining period of the lease with the production capacity of stone i.e. 3040 cum/annum for the remaining period of the lease under the provisions of EIA Notification, 2006 and as amended thereof subject to compliance of EC conditions, general instructions issued vide EC letter dated 17.01.2023. The other terms & conditions of the original EC letter dated 17.01.2023 will remain the same.

8. The SEIAA, Odisha reserves the right to stipulate additional conditions, if found necessary.
9. The Environmental Clearance to the aforementioned project is under provisions of EIA Notification, 2006. It does not tantamount to approvals/consent/permissions etc. required to be obtained under any other Act/Rule/regulation. The Project Proponent is under obligation to obtain approvals /clearances under any other Acts/ Regulations or Statutes, as applicable, to the project.
10. The PP is under obligation to implement commitments made in the Environment Management Plan, which forms part of this EC.

11. This EC is valid for 5 years from date of lease execution or for upto lease period whichever is earlier.

**12. General Instructions:**


1. The project proponent shall prominently advertise it at least in two local newspapers of the District or State, of which one shall be in the vernacular language within seven days indicating that the project has been accorded environment clearance and the details of SEIAA website where it is displayed.
  2. The copies of the environmental clearance shall be submitted by the project proponents to the Heads of local bodies, Panchayats and Municipal Bodies in addition to the relevant offices of the Government who in turn must display the same for 30 days from the date of receipt.
  3. The project proponent shall have a well laid down environmental policy duly approved by the Board of Directors (in case of Company) or competent authority, duly prescribing standard operating procedures to have proper checks and balances and to bring into focus any infringements/deviation/violation of the environmental / forest / wildlife norms / conditions.
  4. Action plan for implementing EMP and environmental conditions along with a responsibility matrix of the project proponent (during construction phase) and authorized entity mandated with compliance of conditions (during operational phase) shall be prepared. The year wise funds earmarked for environmental protection measures shall be kept in a separate account and not to be diverted for any other purpose. Six monthly progress of implementation of the action plan shall be reported to the Ministry/Regional Office along with the Six-Monthly Compliance Report.
  5. Concealing factual data or submission of false/fabricated data may result in revocation of this environmental clearance and attract action under the provisions of Environment (Protection) Act, 1986.
  6. The Regional Office of this MoEF&CC, SPCB and lease granting Authority shall monitor compliance of the stipulated conditions. The project authorities should extend full cooperation to the officer (s) of the Regional Office and other authority by furnishing the requisite data/ information/monitoring reports.
  7. Any appeal against this EC shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.

### Additional EC Conditions

1. The Maximum depth of mining limited to **6.0 meter** from the surface level and maximum quantity of extraction shall be limited to **3040 cum/annum** and the total production in the 5 years lease period will be **15200 cum**.
2. **The nearest Railway line is located 130 meter away from proposed quarry boundary. Hence, the concerned Mining Officer shall ensure that 200 meter safety zone shall be maintained from the Railway line during quarry operation and accordingly safety measure shall be adopted.**
3. The method of mining shall be as per the approved Mining Plan.
4. The EC is valid for the balance lease period subject to the quantity prescribed in the modified DSR or revised Mining Plan whichever is less.
5. The PP shall implement the **cluster** EMP with a budgetary allocation of **Rs. 7,68,000/-** (Capital Cost) **Rs. 4,45,000/-** (Recurring cost) and **Rs.0.30 Lakh/annum** for CER cost as per commitment made in Public hearing issues as proposed in the EMP report during EC application.
6. The PP shall plant **1000 nos. of tree species (under cluster approach)** like Banyan (Ficus benghalensis), Peepal(Ficus religiosa), Neem (Azadirachta indica), Jamun(Syzygium cumini), Mango(Mangifera indica), Karanj(Pongamia pinnata), Arjun(Terminalia Arjuna), Jackfruit (Artocarpus heterophyllus), Siris (Albizia lebbeck), etc.. as part of tree plantation campaign "**Ek Ped Maa Ke Naam**" and the details of the same shall be uploaded in the MeriLiFE Portal (<https://merilife.nic.in>).The PP shall submit the status of plantation during every six-months (06) compliance of EC conditions with geo-coordinating photographs.
7. The compliance of EC conditions of said quarry shall be monitored by DEIAA, concerned lease granting Authority either Mining Officer or Tahasildar, RO, SPCB, Odisha and Integrated Regional Office of MoEFCC, Bhubaneswar as per MoEF & CC, Govt. of India S.O. 141(E) in EIA Notification dated 15.01.2016.
8. The Project Proponent shall upload/submit six monthly EC compliance in the Parivesh Portal of MoEF & CC., Govt. of India only failing which the EC is liable to be revoked.



**1. Proposal in brief:**

The highlights of the proposal as ascertained from the application and as revealed from proceedings/discussion held during the meeting of SEAC/SEIAA, are given as under.

- (i) This is a proposal for Extension of validity of EC of Padampuri Stone Quarry- III about an area of 1.214 Ha. over plot no- 227 & Khata No- 76 at village- Padampuri, Tahasil / District- Nuapada.
- (ii) The project proponent has obtained EC from SEIAA, Odisha vide EC Identification no./letter no. EC23B001OR181870 dated 17.01.2023 and Transfer EC was granted vide letter no. SIA/OR/MIN/297107/2023 dated 15.05.2023 in favour of Tahasildar, Nuapada and later EC transfer on dated 15.05.2023 to Sri Piyush Jain (successful bidder) for Padampuri Stone Quarry- III about an area of 1.214 Ha. over plot no- 227 & Khata No- 76 at village- Padampuri, Tahasil / District- Nuapada.
- (iii) The EC granted dated 17.01.2023 for extraction quantity of stone 3040 cum/annum for 1<sup>st</sup> and 2<sup>nd</sup> year subject to submission of compliance report of EC conditions.
- (iv) The PP has submitted earlier EC compliance with mentioned that 3040 cum of stone has been extracted from the source in 1<sup>st</sup> and 2<sup>nd</sup> year. Also, deposited the amounting of Rs. 45,000/- to DES, Nuapada for raising tree plantation as per EC conditions.
- (v) Any deficiencies/omission have been noticed in the above documents- Nil

2. **Whether SEAC recommended the proposal** – Yes, the proposal was placed in the SEAC meeting held on 12.02.2025 and the SEAC decided to recommend the proposal for extension of EC validity for the remaining period.

**Decision of Authority: Deferred for ADS**

The proposal was placed in the 191<sup>st</sup> meeting of SEIAA and was decided that after detailed deliberation, the authority decided to seek clarification/information on the following:

1. Since, the KML file of lease area superimposed on the google Earth Pro Image shows the presence of a Railway line at a distance of 130 meter, the PP/Mining officer shall submit a revised KML file of lease area accordingly maintaining the minimum distance criteria of 200 meters from Railway line.

**Compliance to the ADS:** Now the project proponent has submitted their clarification for consideration of EC with an undertaking that 200 meters safety zone shall be maintained from the Railway Line and have submitted a revised KML file superimposed on the map.
