1. In view of the particulars given in the Para 1 above, the project proposal inter alia including Form-2(Part A & B)/EMP Reports were submitted to the SEIAA for an appraisal by the SEAC under the provision of EIA notification 2006 and its subsequent amendments.

2. The above-mentioned proposal has been considered by SEIAA in the meeting held on 08/12/2024. The minutes of the meeting and all the project documents are available on PARIVESH portal which can be accessed from the PARIVESH portal by scanning the QR Code above.

3. The SEAC, based on information submitted viz: Form2 (Part A, B)EMP report etc., & clarifications provided by the project proponent and after detailed deliberations on all technical aspects and compliance thereto furnished by the Project Proponent, recommended the proposal for grant of Environment Clearance under the provision of EIA Notification, 2006 and as amended thereof subject to stipulation of Specific and Standard EC conditions as detailed in the point below.

4. The SEIAA has examined the proposal in accordance with the provisions contained in the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and based on the recommendations of the SEAC hereby accords Environment Clearance for the instant proposal to **Thiru. R. Kumar** under the provisions of EIA Notification, 2006 and as amended thereof subject to compliance of the Specific and Standard EC conditions as given in Annexure (2)

5. The Ministry/SEIAA-TN reserves the right to stipulate additional conditions, if found necessary.

6. The Environmental Clearance to the aforementioned project is under provisions of EIA Notification, 2006. It does not tantamount to approvals/consent/permissions etc. required to be obtained under any other Act/Rule/regulation. The Project Proponent is under obligation to obtain approvals /clearances under any other Acts/ Regulations or Statutes, as applicable, to the project.

Validity:

This Environmental Clearance is accorded for the quantity of exceeding 52,775m³ of Rough Stone & 9,620m³ of Gravel and the annual peak production shall not exceed 11,880m³ of Rough Stone & 3,900m³ of Gravel by restricting the maximum depth of mining upto 27m BGL.

The Environmental Clearance issued is valid as per the approved mine plan period and as per MoEF&CC's notification S.O.1533 (E) dated 14.09.2006 and S.O. 1807(E) dated 12.04.2022.

9.General Instructions:

(i)The project proponent shall prominently advertise it at least in two local newspapers of the District or State, of which one shall be in the vernacular language within seven days indicating that the project has been accorded environment clearance and the details of SEIAA website where it is displayed.

(ii)The copies of the environmental clearance shall be submitted by the project proponents to the Heads of local bodies, Panchayats and Municipal Bodies in addition to the relevant offices of the Government who in turn must display the same for 30 days from the date of receipt.

(iii)The project proponent shall have a well laid down environmental policy duly approved by the Board of Directors (in case of Company) or competent authority, duly prescribing standard operating procedures to have proper checks and balances and to bring into focus any infringements/deviation/violation of the environmental / forest / wildlife norms / conditions.

(iv)Action plan for implementing EMP and environmental conditions along with responsibility matrix of the project proponent (during construction phase) and authorized entity mandated with compliance of conditions (during operational phase) shall be prepared. The year wise funds earmarked for environmental protection measures shall be kept in separate account and not to be diverted for any other purpose. Six monthly progress of implementation of action plan shall be reported to the Ministry/Regional Office along with the Six-Monthly Compliance Report.

(v)Concealing factual data or submission of false/fabricated data may result in revocation of this environmental clearance and attract action under the provisions of Environment (Protection) Act, 1986.

The Regional Office of this SEIAA shall monitor compliance of the stipulated conditions. The project authorities should extend full cooperation to the officer (s) of the Regional Office by furnishing the requisite data / information/monitoring reports.

(vi)Any appeal against this EC shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.

| 1.1 | <p>After detailed discussions, the Authority taking into account the recommendations of SEAC and also the safety aspects and to ensure sustainable, scientific and systematic mining, decided to grant Environmental Clearance for the production quantity of 52,775m³ of Rough Stone & 9,620m³ of Gravel and the annual peak production shall not exceed 11,880m³ of Rough Stone & 3,900m³ of Gravel by restricting the maximum depth of mining upto 27m BGL for a period of five year . This is also subject to the conditions imposed by SEAC, normal conditions stipulated by MOEF&CC in addition to the following conditions and the conditions in Annexure of this minutes.</p> <ol style="list-style-type: none"> 1. The removal of Rough stone & gravel should not disturb the agriculture/horticulture activities, biodiversity & drainage pattern. 2. The proposed activity should in no way cause any impact on the livelihoods and road situated adjacent to the proposed mine area. 3. No mining/Production activity should be outside the mine lease area. 4. Keeping in view of MoEF&CC's notification S.O.1533(E) dated.14.09.2006 and S.O. 1807(E) dated 12.04.2022, this Environmental Clearance is valid as per the approved mine plan period. 5. The topsoil/side burden/weathered rock should be used only for the purpose of progressive mine closure. Further, non-recoverable reserves i.e., mined waste should be used for filling of mines & restoration of mining sites. 6. The EC granted is subject to review by District Collector, Mines Dept. and TNPCB on completion of every 5 years and also during the mine plan period, till the project life so as to review the EC conditions and to ensure that they have all been adhered to and implemented. 7. The project proponent shall submit a Certified Compliance Report obtained from IRO of MoEF&CC to the monitoring, regulatory and other concerned authorities including SEIAA, while seeking a renewal of the mining plan to cover the project life. 8. There should be regular monitoring of air quality, water quality, ground water level and noise quality and reports regarding the same should be submitted to TNPCB, SEIAA & IRO of MoEF&CC once in every 6 months. 9. The proponent shall strictly adhere to the mining plan and half yearly and annual returns shall be submitted to the Director of Geology and Mining Department with copy marked to TNPCB, SEIAA & IRO of MoEF&CC. 10. Biodiversity in and around the project area should be monitored frequently and detailed biodiversity report should be submitted every year to SEIAA & IRO of MoEF&CC. |

SEAC SPECIFIC CONDITIONS:

- 1) The prior Environmental Clearance granted for this mining project shall be valid subject to the standard conditions as per the **Annexure I** of this minutes & normal conditions stipulated by MOEF &CC.
- 2) The PP shall mark the DGPS reference pillars painted with blue & white colour indicating the safety barrier of 7.5 m to be left under the Rule 13 (1) of MCDR, 1988 within the lease boundary and protective bunds, before obtaining the CTO from the TNPCB.
- 3) Tree plantation & fencing and installation of garland drainage with siltation tank around the mine lease area shall be completed before execution of the mine lease.
- 4) The AD (Mines) shall ensure the mining operation is carried out scientifically and systematically following the Regulations of MMR 1961 without deviation.
- 5) The PP shall **register promptly through online in the Shram Suvidha Portal** which is the official portal of Ministry of Labour & Employment, Govt of India to obtain **Labour Identification Number (LIN) before obtaining the CTO from the TNPCB.**
- 6) For ensuring the safe and systematic mining operations, the PP shall send the 'Notice of Opening' indicating the appointment of **First Class/Second Class Mine Manager** for managing the quarrying operations and the proposed usage of HEMM shall be sent to the Director of Mines Safety, Chennai Region of the Mine under the provisions of MMR 1961 at least 30 days before the commencement of the mining operation immediately after the execution of lease with district authority.
- 7) The PP shall not employ any external agency for carrying out the blasting operation and he shall also install the temporary magazines approved by the concerned licensing authority before the execution of the lease, for storing the authorized explosives & detonators separately in accordance with the Explosive Rules, 2008.
- 8) **Since the structures are situated within a radial distance of 500 m**, the PP shall carry out only one blast per day with muffle technique, for not more than 30 to 40 holes in a round, with maximum charge of 375g/hole.

(S&T) Circular No. 01 of 2011**, on OHS of the persons working in mines prone to generate the airborne dust, under Section 9A of Mines Act, 1952 by actively involving State Government officials and Non-Government Organizations (NGO) working in the Occupational Health Survey (Medical Examination). A copy of such annual compliance certificate shall be submitted to the SEIAA, MoEF, TNPCB, AD/Mines-DGM and DMS, Chennai as a part of Environmental Compliance without any deviation.
- 11) As accepted by the Project Proponent the CER cost of Rs. 7 lakhs and the amount shall be spent for the Government High School Avalur Village, Walajabad Taluk, Kanchipuram District before obtaining CTO from TNPCB.

SEAC STANDARD CONDITIONS:

- 1) The proponent shall mandatorily appoint the statutory competent persons and commence the quarry operations within the purview of Mines Act 1952.
- 2) The proponent shall erect fencing all around the boundary of the proposed area with gates for entry/exit before the commencement of the operation and shall furnish the photographs/map showing the same before obtaining the CTO from TNPCB.
- 3) Perennial maintenance of haulage road/village / Panchayat Road shall be done by the project proponent as required in connection with the concerned Govt. Authority.
- 4) The Project Proponent shall adhere to the working parameters of mining plan which was submitted at the time of EC appraisal wherein year-wise plan was mentioned for total excavation. No change in basic mining proposal shall be carried out without prior approval of the Ministry of Environment, Forest and Climate Change, which entail adverse environmental impacts, even if it is a part of approved mining plan modified after grant of EC or granted by State Govt. in the form of Short-Term Permit (STP), Query license or any other name.

- 5) Perennial sprinkling arrangement shall be in place on the haulage road for fugitive dust suppression. Fugitive emission measurements should be carried out during the mining operation at regular intervals.
- 6) The Proponent shall ensure that the noise level is monitored during mining operation at the project site for all the machineries deployed and adequate noise level reduction measures undertaken accordingly.
- 7) Proper barriers to reduce noise level and dust pollution should be established by providing greenbelt along the boundary of the quarrying site and suitable working methodology to be adopted by considering the wind direction.
- 8) The purpose of green belt around the project is to capture the fugitive emissions, carbon sequestration and to attenuate the noise generated, in addition to improving the aesthetics.
- 9) Taller/one year old saplings raised in appropriate size of bags (preferably eco-friendly bags) should be planted in proper spacing as per the advice of local forest authorities/botanist/horticulturist with regard to site specific choices. The proponent shall earmark the greenbelt area with GPS coordinates all along the boundary of the project site with at least 3 meters wide and in between blocks in an organized manner.
- 10) **Noise and Vibration Related:** (i) Appropriate measures should be taken for control of noise levels below 85 dBA in the work environment. Workers engaged in operations of HEMM, etc. should be provided with ear plugs/muffs, (iii) Noise levels should be monitored regularly (on weekly basis) near the major sources of noise generation within the core zone.
- 11) The operation of the quarry should not affect the agricultural activities & water bodies near the project site and a 50 m safety distance from water body should be maintained without carrying any activity. The proponent shall take appropriate measures for “Silt Management” and prepare a SOP for periodical de-siltation indicating the possible silt content and size in case of any agricultural land exists around the quarry.
- 12) The proponent shall provide sedimentation tank / settling tank with adequate capacity for runoff management.
- 13) The proponent shall ensure that the transportation of the quarried granite stones shall not cause any hindrance to the Village people/Existing Village Road and shall take adequate safety precautionary measures while the vehicles are passing through the schools / hospital. The Project Proponent shall ensure that the road may not be damaged

- due to transportation of the quarried granite stones; and transport of granite stones will be as per IRC Guidelines with respect to complying with traffic congestion and density.
- 14) To ensure safety measures along the boundary of the quarry site, security guards are to be posted during the entire period of the mining operation.
 - 15) The Project Proponent shall comply with the provisions of the Mines Rules 1955 for ensuring safety, health and welfare of the people working in the mines and the surrounding habitans.
 - 16) The project proponent shall ensure that the provisions of the MMDR Act, 1957, the MCDR 2017 and Tamilnadu Minor Mineral Concession Rules 1959 are complied by carrying out the quarrying operations in a skillful, scientific and systematic manner keeping in view proper safety of the labour, structure and the public and public works located in that vicinity of the quarrying area and in a manner to preserve the environment and ecology of the area.
 - 17) The quarrying activity shall be stopped if the entire quantity indicated in the Mining plan is quarried even before the expiry of the quarry lease period and the same shall be informed to the District AD/DD (Geology and Mining) District Environmental Engineer (TNPCB) by the proponent without fail.
 - 18) The Project Proponent shall abide by the annual production scheduled specified in the approved mining plan and if any deviation is observed, it will render the Project Proponent liable for legal action in accordance with Environment and Mining Laws.
 - 19) Prior clearance from Forestry & Wild Life including clearance from committee of the National Board for Wildlife as applicable shall be obtained before starting the quarrying operation, if the project site attracts the NBWL clearance, as per the existing law from time to time.
 - 20) All the conditions imposed by the Assistant/Deputy Director, Geology & Mining, concerned District in the mining plan approval letter and the Precise area communication letter issued by concerned District Collector should be strictly followed.

STANDARD CONDITION

Part-A: Conditions to be Complied before commencing mining operations: -

1. The project proponent shall advertise in at least two local newspapers widely circulated in the region, one of which shall be in the vernacular language informing the public that
 - I. The project has been accorded Environmental Clearance.
 - II. Copies of clearance letters are available with the Tamil Nadu Pollution Control Board.
 - III. Environmental Clearance may also be seen on the website of the SEIAA.

IV. The advertisement should be made within 7 days from the date of receipt of the clearance letter and a copy of the same shall be forwarded to the SEIAA.

1. The project proponent shall comply the conditions laid down in the Section V, Rule 36 of Tamil Nadu Minor Minerals Concession Rules 1959.
2. A copy of the Environment Clearance letter shall be sent by the proponent to the concerned Panchayat, Town Panchayat / Panchayat union/ Municipal Corporation, Urban Local Body and the Local NGO, if any, from whom suggestions/ representations, if any, were received while processing the proposal. The clearance letter shall also be put on the website of the proponent and also kept at the site, for the general public to see.
3. The proponent shall ensure that First Aid Box is available at site.
4. The excavation activity shall not alter the natural drainage pattern of the area.
5. The excavated pit shall be restored by the project proponent for useful purposes.
6. The proponent shall quarry and remove only in the permitted and approved areas.
7. The proponent shall do the quarrying as per the approved mining plan.
8. It shall be ensured that the quarrying operation shall be carried out between 7AM and 5 PM.
9. The proponent shall take necessary measures to ensure that there shall not be any adverse impacts due to quarrying operation on the nearby human habitations, by way of pollution to the environment.
10. The mined out pits should be backfilled wherever warranted and area should be suitably landscaped to prevent environmental degradation. The mine closure plan as furnished in the proposal shall be strictly followed. The District administration should ensure the fully implementation of mine closure plan before release of lease deed.
11. No drilling and blasting operation shall be carried out under any circumstances.
12. Free silica test should be conducted and reported.
13. Air Sampling at intersection point should be conducted and reported.
14. Bunds to be provided at the boundary of the project site.
15. Rainwater shall be pumped out via settling tank only
16. The project proponent shall undertake plantation/afforestation work by planting the native species on all side of the lease area
17. Earthen bunds and barbed wire fencing around the pits all along the boundary shall be maintained.

18. The CSR funds should be channelized for planting programme, nature conservation support, tribal development and activities that support forest and environment.
19. As per MoEF & CC, GoI, Office Memorandum dated 30.03.2015, prior clearance from Forestry & Wildlife angle including clearance from obtaining committee of the National Board for Wildlife as applicable shall be obtained before starting the quarrying operation, if the project site is located within 10KM from National Park and Sanctuaries.
20. Necessary allocation of funds for implementation of the conservation plan shall be made and the funds so allocated shall be included in the project cost. A copy of action plan shall be submitted to the Regional Office of the Ministry of Environment and Forests, Chennai.
21. It shall be ensured that the total extent of Mining area including existing, abandoned and proposed shall not exceed 5 Ha within 500 meter radius from the boundary of this quarry within the mining lease period of this application. If the area exceeds, the applicant has to obtain fresh Environmental Clearance submitting EIA Study Report under Category “B1” (As per the order of Hon’ble NGT, PB, New Delhi in O.A No.186 of 2016 (M.A.No.350/2016), O.A.No.200/2016, O.A.No.580/2016 (M.A.No.1182/2016), O.A.No.102/2017, O.A.No.404/ 2016 (M.A.No.758/2016, M.A. No. 920 /2016, M.A.No.1122/2016, M.A.No.12/2017 & M.A.No.843/2017), O.A.No.405/2016 and O.A.No.520 of 2016 (M.A.No.981/2016, M.A.No.982/2016 & M.A.No.384/2017).
22. It shall be ensured that there is no habitation is located within 300 meter radius from the periphery of the quarry site.
23. Whenever/wherever, “Savudu” /” Red Earth” /”Brick Earth” are removed from tanks, the project proponents should see that the free flow of water from and into the tanks are ensured through maintenance of inlet and outlet channels. Removal Earth should be in smooth, sloppy way towards deeper portion of the tank.
24. The Assistant/Deputy Director of Geology & Mining shall ensure that the total extent of mining area within 500m radius of this quarry not exceeds 5ha before execution of the quarry lease proceedings. (As per the order of Hon’ble NGT, PB, New Delhi in O.A No.186 of 2016 (M.A.No.350/2016), O.A.No.200/2016, O.A.No.580/2016 (M.A.No.1182/2016), O.A.No.102/2017, O.A.No.404/ 2016 (M.A.No.758/2016, M.A.No.920/2016, M.A.No.1122/2016, M.A.No.12/2017 & M.A.No.843/2017),

O.A.No.405/2016 and O.A.No.520 of 2016 (M.A.No.981/2016, M.A.No.982/2016 & M.A.No.384/2017).

25. The Assistant Director of Geology & Mining shall monitor the quantity of minerals excavated and ensure that resources other than the approved minerals shall not be excavated from the approved Mining area. The Department of Geology & Mining is responsible for the enforcement of Tamil Nadu Minor Mineral Concession Rules, 1959 and any violation shall be punished according to the said Act.
26. The Project Proponent shall obtain & furnish the letter /certificate from the Assistant Director of Geology and Mining stating that there is no other Minerals/resources like sand in the quarrying area below the approved depth of Mining before execution of Mining lease.
27. The Proponent shall ensure that the project activity including mining transportation etc should in no way have adverse impact to the other forests, such as reserve forests and social forests, tree plantation and bio diversity, surrounding water bodies etc.
28. The Project Proponent is also directed to strictly adhere to the Sustainable Sand Mining Management Guidelines, 2016, wherever applicable.
29. The depth of the mining should be limited to the sill level of the sluice of the tank.
30. Floor of excavated pit should be levelled and sides to be sloped gently in the mine closure phase.
31. All the commitment made by the project proponent in the proposal shall be strictly followed.
32. The mining lease holder shall, after ceasing mining operations, undertake re-grassing the mining area and any other area which may have been disturbed due to their mining activities and restore the land to a condition which is fit for growth of fodder, flora, fauna etc.

Part B: General Conditions:

1. EC is given only on the factual records, documents and the commitment furnished in non judicial stamp paper by the proponent.
2. The Proponent shall obtain the Consent from the TNPC Board before commencing the activity.
3. No change in mining technology and scope of working should be made without prior approval of the SEIAA, Tamil Nadu.

4. No change in the calendar plan including excavation, quantum of mineral (minor mineral) should be made.
5. Effective safeguard measures, such as regular water sprinkling shall be carried out in critical areas prone to air pollution and having high levels of particulate matter such as loading and unloading point and all transfer points. Extensive water sprinkling shall be carried out on haul roads. It should be ensured that the Ambient Air Quality parameters conform to the norms prescribed by the Central Pollution Control Board in this regard.
6. Effective safeguards shall be adopted against health risks on account of breeding of vectors in the water bodies created due to excavation of earth.
7. A berm shall be left from the boundary of adjoining field having a width equal to at least half the depth of proposed excavation.
8. Loading and unloading areas including all the transfer points should also have efficient dust control arrangements. These should be properly maintained and operated.
9. Vehicular emissions shall be kept under control and be regularly monitored. The mineral transportation shall be carried out through the covered trucks only and the vehicles carrying the mineral shall not be overloaded.
10. Access and haul roads to the quarrying area should be restored in a mutually agreeable manner where these are considered unnecessary after extraction has been completed.
11. All Personnel shall be provided with protective respiratory devices including safety shoes, masks, gloves etc. Supervisory people should be provided with adequate training and information on safety and health aspects. Occupational health surveillance program of the workers should be undertaken periodically to observe any contractions due to exposure to dust and take corrective measures, if needed.
12. Periodical medical examination of the workers engaged in the project shall be carried out and records maintained. For the purpose, schedule of health examination of the workers should be drawn and followed accordingly. The workers shall be provided with personnel protective measures such as masks, gloves, boots etc.
13. Workers/labourers shall be provided with facilities for drinking water and sanitation facility for Female and Male separately.
14. The project proponent shall ensure that child labour is not employed in the project as per the sworn affidavit furnished.
15. The funds earmarked for environmental protection measures should be kept in separate account and should not be diverted for other purpose. Year wise expenditure should be

reported to the Ministry of Environment and Forests and its Regional Office located at Chennai.

16. The Environmental Clearance does not absolve the applicant/proponent of his obligation/requirement to obtain other statutory and administrative clearances from other statutory and administrative authorities.
17. This Environmental Clearance does not imply that the other statutory / administrative clearances shall be granted to the project by the concerned authorities. Such authorities would be considering the project on merits and be taking decisions independently of the Environmental Clearance
18. The SEIAA, Tamil Nadu may alter/modify the above conditions or stipulate any further conditions in the interest of environment protection.
19. The SEIAA, Tamil Nadu may cancel the Environmental Clearance granted to this project under the provisions of EIA Notification, 2006, at any stage of the validity of this Environmental Clearance, if it is found or if it comes to the knowledge of this SEIAA, TN that the project proponent has deliberately concealed and/or submitted false or misleading information or inadequate data for obtaining the Environmental Clearance.
20. Failure to comply with any of the conditions mentioned above may result in withdrawal of this clearance and attract action under the provisions of the Environment (Protection) Act, 1986.
21. The above conditions will be enforced inter-alia, under the provisions of the Water (Prevention & Control of Pollution) Act, 1974, the Air (Prevention & Control of Pollution) Act, 1981, the Environment (Protection) Act, 1986, the Public Liability Insurance Act, 1991, along with their amendments, Minor Mineral Conservation & Development Rules, 2010 framed under MMDR Act 1957, National Commission for protection of Child Right Rules, 2006, Wildlife Protection Act, 1972, Forest Conservation Act, 1980, Biodiversity Conservation Act, 2016, the Biological Diversity Act, 2002 and Biological diversity Rules, 2004 and Rules made there under and also any other orders passed by the Hon'ble Supreme Court of India/Hon'ble High Court of Madras and any other Courts of Law relating to the subject matter.
22. Any other conditions stipulated by other Statutory/Government authorities shall be complied.

23. Any appeal against this Environmental Clearance shall lie with the Hon'ble National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.
24. The Environmental Clearance is issued based on the documents furnished by the project proponent. In case any documents found to be incorrect/not in order at a later date the Environmental Clearance issued to the project will be deemed to be revoked/ cancelled.
