3. SEIAA, Chhattisgarh in its 186th Meeting held on 25/02/2025. Perused the application submitted by the project proponent and minutes of the meeting of SEAC-3, Chhattisgarh in the 556th meeting held on 28/01/2025. It is noted that TOR (with Public Hearing) was already granted vide letter no 936 dated 22/08/2024 in the same

proposal number in PARIVESH Portal 1.0. Due to some technical error in the parivesh portal, application was again shown in the PARIVESH 2.0 and came in to the agenda. In view of the above facts, after due deliberation by the Authority, it was unanimously decided that decision will be applicable as per previous TOR issued on 22/08/2024.

In view of the particulars given in the Para 1 above, the project proposal interalia including Form-1(Part A and B) were submitted to the Ministry for an appraisal by the State Environment Impact Assessment Authority(SEIAA) Appraisal Committee (SEIAA) in the Ministry under the provision of EIA notification 2006 and its subsequent amendments.
5. The above-mentioned proposal has been considered by State Environment Impact Assessment Authority(SEIAA) Appraisal Committee of SEIAA in the meeting held on 25/02/2025. The minutes of the meeting and all the Application and documents submitted [(viz. 6. The brief about configuration of plant/equipment, products and byproducts and salient features of the project along with environment settings, as submitted by the Project proponent in Form-1 (Part A, B and C)/EIA & EMP Reports/presented during SEIAA are annexed to this EC as Annexure (1).
7. The SEIAA, in its meeting held on 25/02/2025, based on information & clarifications provided by the project
8. proponent and after detailed deliberations recommended the proposal for grant of Terms of Reference under the provision of EIA Notification, 2006 and as amended thereof subject to stipulation of specific and general conditions as detailed in Annexure (2).

The SEIAA has examined the proposal in accordance with the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and after accepting the recommendations of the State Environment Impact Assessment Authority(SEIAA) Appraisal Committee hereby decided to grant Terms of Reference for instant proposal of M/s. RAMESH SURANA under the provisions of EIA Notification, 2006 and as amended thereof.
10. The Ministry reserves the right to stipulate additional conditions, if found necessary.
11. The Terms of Reference to the aforementioned project is under provisions of EIA Notification, 2006. It does not tantamount to approvals/consent/permissions etc. required to be obtained under any other Act/Rule/regulation.
