This is in reference to your application submitted to Ministry vide proposal number SIA/CG/MIN/484259/2024 dated null for Rejection of prior Environmental Clearance (EC) to the project under the provision of the EIA Notification 2006-and as amended thereof.

1. SEIAA, Chhattisgarh in its 186th Meeting held on 25/02/2025 perused the application submitted by the project proponent and minutes of the 556th meeting of SEAC-3 held on 28/01/2025. It is noted that the Project Proponent has excavated 7,308 tonnes in the year 2021-22. The project proponent has excavated more than the granted quantity (6,840 tonnes per year) mentioned in the issued environmental clearance, which falls in the category of violation. Ministry of Environment, Forest and Climate Change issued Standard Operating Procedure vide Office Memorandum dt.07.07.2021 regarding identification and handling of violation cases under EIA Notification 2006 in compliance to order of Hon'ble National Green Tribunal in O.A. No.34/2020. In this Office Memorandum para 11 (B) (i) following is mentioned:- "As per extant regulations at the time of scoping, if it is viewed that the project activity is otherwise permissible, Terms of Reference (TOR) shall be issued with directions to complete the impact assessment studies & submit Environmental Impact Assessment (EIA) report & Environmental Management Plan (EMP) in a time bound manner." As per the above OM and the applied case is a violation, project proponent needs to apply for TOR, but project proponent has applied directly for Environment Clearance. SEIAA, Chhattisgarh unanimously accepted the recommendation of SEAC-3 and decided to delist/reject the applied case.
2. In view of the particulars given in the Para 1 above, the project proposal interalia including Form-1(C)/ EIA & EMP Reports were submitted to the Ministry for an appraisal by the Expert Appraisal Committee (SEIAA) in the Ministry under the provision of EIA notification 2006 and its subsequent amendments.
3. The above-mentioned proposal has been considered by Expert Appraisal Committee of in the meeting held on 25/02/2025. The minutes of the meeting and all the Application and documents submitted [(viz. Form-1 Part A, Part B, Part C EIA, EMP)] are available on PARIVESH portal which can be accessed by scanning the QR Code above.
4. The brief about configuration of plant/equipment, products and byproducts and salient features of the project along with environment settings, as submitted by the Project proponent in Form-1 (C)/EIA & EMP Reports/presented during are annexed to this EC as Annexure (1) and Annexure (2).
5. The SEIAA, in its meeting held on 25/02/2025 , based on information & clarifications provided by the project proponent and after detailed deliberations recommended the proposal for Rejection of Environment Clearance under the provision of EIA Notification, 2006 and as amended.
6. The MoEF&CC has examined the proposal in accordance with the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and after accepting the recommendations of the Expert Appraisal Committee hereby decided to Reject Environment Clearance for instant proposal of M/s. RAMGOPAL NETAM under the provisions of EIA Notification, 2006 and as amended thereof.
7. This issues with the approval of the Competent Authority.
