

Sir/Madam,

This has reference to your online application no. SIA/OR/MIN/461056/2024 dated 05.02.2024, wherein you have requested for amendment (i.e. amendment of EC regard to annual production of sand as per replenishment study report) of Environmental Clearance (EC) granted by SEIAA, Odisha vide letter no./EC Identification No. EC22B001OR118066 dt. 05.11.2022 in favour Sri. Rasmi Ranjan Patra, the successful bidder/lessee.

2. The application was examined in the State Environment Impact Assessment Authority (SEIAA), Odisha in its 165<sup>th</sup> meeting held on 30.04.2024 & 02.05.2024 in accordance with the EIA Notification, 2006 as amended from time to time and the following points are noted;

- (i) This is a proposal for amendment of EC of Sukunabhata Sand Bed over an area of 10.00 Acres or 4.048 Hectares in village Sukunabhata under Titlagarh tahasil of Balangir district.
- (ii) The project proponent has obtained EC from SEIAA, Odisha vide EC letter no. EC Identification No. – EC22B001OR118066 dt. 05.11.2022 for Sukunabhata Sand Bed over an area of 10.00 Acres or 4.048 Hectares in village Sukunabhata under Titlagarh Tahasil of Balangir district.
- (iii) During EC application the PP has submitted required documents along with mining plan where it is mentioned that mineable reserve of the proposed sand was 30333 cum with depth of sand deposition was 1.5 meter and proposed for annual extraction-3000 cum.
- (iv) The SEIAA allowed the production quantity of sand 3000 cum for the 1<sup>st</sup> year and 750 cum in 2<sup>nd</sup> year (if, ARRS report is not submitted after one year).
- (v) The PP has not submitted the quantity of sand extracted from the source and quarry operation period.
- (vi) The replenishment study was done by the M/s. Areal Constructions & Geo -India Services, the ORSAC empanel agency with mentioned that the Pre-Monsoon Standard Elevation = 188.0575 and Post-Monsoon

Standard Elevation = 189.7596 and quantity of sand replenished is 51393.63 cum and proposed production is 30836 cum.

- (vii) Documents submitted for amendment of EC;
- Form No. 4 for amendment of Environmental Clearance,
  - Replenishment study report
3. The proposal was placed in SEAC meeting held on 26.02.2024 and the SEAC decided to recommend the proposal as per the replenishment study report submitted. The replenished volume of sand is 51393.6329cum which is recommended for extraction for next year subjected to approval of Modified Mining Plan from competent authority of Mining & Geology Department, Odisha.
4. Amendment of Environmental Clearance (EC) letter no./Identification no. EC22B001OR118066 dt. 05.11.2022 issued for Sukunabhata River Sand Quarry in favour of Sri. Rasmi Ranjan Patra is **allowed** for extraction quantity of sand **51393 cum per annum** for rest of the lease period i.e. for 2<sup>nd</sup> year, 3<sup>rd</sup> year, 4<sup>th</sup> year and 5<sup>th</sup> year. The other stipulated terms and conditions of the original EC initially granted remains same subject to satisfactory compliance to all the stipulated terms and conditions of EC along with following additional stipulation:

**Additional stipulation**

- The project proponent is required to obtain modified mining plan from the Mines & Geology Deptt. Govt. of Odisha & revision of lease sanction order from the competent Authority on the basis of approved extraction quantity of sand i.e. 51393 cum/annum as ARRS report.
- The PP is required to carry out the Annual rate of replenishment study (ARRS) through ORSAC empanel agency in subsequent year and submit the report to SEIAA, Odisha.
- The validity of EC is for validity of DSR or validity of lease period whichever is earlier.
- The Project Proponent (lease holder) shall deposit Rs.2,25,000/-, with the respective District Environment Society for raising 500 plants (minimum @100 trees per Ha) of native species within 2 years in a suitable location adjoining to quarry.
- The PP will implement the EMP with a budgetary allocation as proposed in the EMP report during EC application.

The Project Proponent shall upload/submitted six monthly EC compliance in the Parivesh Portal of MoEF & CC., Govt. of India only within six months (06) from date of issue of transfer of EC, failing which the EC is liable to be revoked.

In case, there is a change in the scope of the project, fresh Environment Clearance shall be obtained.
