Sir/Madam,

This is in reference to your application for Grant of EC under the provision of the EIA Notification 2006-regarding in respect of project Ordinary Earth Mining submitted to Ministry vide proposal number SIA/UP/MIN/458955/2024 dated 16/01/2024.

3. In view of the particulars given in the Para 1 above, the project proposal interalia including Form-1(Part A and B) were submitted to the SEAC for appraisal under the provision of EIA notification 2006 and its subsequent amendments.

4. The above-mentioned proposal has been considered by **SEAC in its meeting held on 27-02-2024**. The minutes of the meeting and all the Application and documents submitted [(viz. Form-1 Part A, Part B, Part C EIA, EMP)] are

available on PARIVESH portal which can be accessed by scanning the QR Code above.

5. The brief about configuration of plant/equipment, products and byproducts and salient features of the project along with environment settings, as submitted by the Project proponent in Form-1 (Part A, B and C)/EIA & EMP Reports/presented during SEAC meeting are annexed to this EC as Annexure (2).

6. The **SEAC, in its meeting held on 27-02-2024**, based on information & clarifications provided by the project proponent and after detailed deliberations recommended the proposal for grant of EC under the provision of EIA Notification, 2006 and as amended thereof subject to stipulation of specific and general conditions as detailed in Annexure (1).

7. The **SEIAA in its meeting held on 21-03-2024** has examined the proposal in accordance with the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and after accepting the recommendations of the SEAC hereby decided to grant EC for instant proposal of **M/s RINKU SINGH** under the provisions of EIA Notification, 2006 and as amended thereof.

8. The SEIAA, U.P. reserves the right to stipulate additional conditions, if found necessary.

9. The EC to the aforementioned project is under provisions of EIA Notification, 2006. It does not tantamount to approvals/consent/permissions etc. required to be obtained under any other Act/Rule/regulation. The Project Proponent is under obligation to obtain approvals /clearances under any other Acts/ Regulations or Statutes, as applicable, to the project.

10. General Instructions:-

a) The project proponent shall prominently advertise it at least in two local newspapers of the District or State, of which one shall be in the vernacular language within seven days indicating that the project has been accorded environment clearance and the details of SEIAA website where it is displayed.

b) The copies of the environmental clearance shall be submitted by the project proponents to the Heads of local bodies, Panchayats and Municipal Bodies in addition to the relevant offices of the Government who in turn must display the same for 30 days from the date of receipt.

c) Concealing factual data or submission of false/fabricated data may result in revocation of this environmental clearance and attract action under the provisions of Environment (Protection) Act, 1986.

d) The project proponent shall also ensure that the proposed site is not a part of any no-development zone as required/prescribed/identified under law. In case of violation, this permission shall automatically deem to be cancelled. Also, in the event of any dispute on ownership or land use of the proposed site, this clearance shall automatically deem to be cancelled.

e) Any appeal against this EC shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.

f)The SEIAA reserves the right to revoke the environmental clearance, if conditions stipulated are not implemented to the satisfaction of SEIAA.

11. SEIAA may impose additional environmental conditions or modify the existing ones, if necessary.


1. Environmental Attributes

1.1	<p><u>General condition:</u></p> <p>1- This environmental clearance does not create or verify any claim of applicant on the proposed site/activity.</p> <p>2. Any mining activity shall be undertaken only after valid permission from Mining Department/District Administration and written agreement with land owner from where earth excavation is proposed.</p> <p>3. No change is mining technology and scope of working shall be made without approval of</p>

	<p>Authority.</p> <p>4. Personnel working in dusty areas shall be provided with protective respiratory devices and they shall also be imparted adequate training and information on safety and health aspects.</p> <p>5. The Authority reserves the right to revoke the clearance if conditions stipulated are not implemented. The Authority will also be entitled to impose additional environmental conditions or modify the existing ones, if necessary.</p> <p>6. In case of any deviation or alteration in the project proposed from those submitted to this Authority for clearance, a fresh reference should be made to the Authority to assess the adequacy of the condition(s) imposed and to add additional environmental protection Measures required, if any.</p> <p>7. Concealing factual data or submission of false/fabricated data and failure to comply with any of the conditions mentioned above may result in withdrawal of this clearance and attract action under the provisions of Environment (Protection) Act, 1986.</p> <p><u>Specific Conditions:</u></p> <p>1. The Environmental clearance will be co-terminus with the agreement/mining plan whichever is earlier.</p> <p>2. Environment management should be in accordance with the present environment status of the project.</p> <p>3. Approach kaccha road should be made motorable and maintained periodically.</p> <p>4. Transportation of soil should be undertaken in covered containers.</p> <p>5. Rehabilitation plan with planting of trees to be submitted along with the closure plan.</p> <p>6. Land to be leveled and handed over to the owners after completion of excavation work.</p> <p>7. The mining operations shall be strictly limited to the proposed mining sites and proposed purpose.</p> <p>8. Top soil should be adequately preserved and should be used for landscaping.</p> <p>9. Excavated soil should be properly stored in a manner not to increase surrounding air pollution level.</p> <p>10. Water sprinkling should be exercised during excavation and storage of soil for suppression of fugitive dust.</p> <p>11. Excavated area should be properly reclaimed and ensured that no open bore hole is left.</p> <p>12. Safety measures for the people working at the site shall be duly taken care of as per law.</p> <p>13. The excavation work shall be done in day time only.</p> <p>14. The project boundary shall be properly covered to restrict dust dispersion.</p> <p>15. Precautionary measures during soil excavation for conservation and protection of rare and endangered flora and fauna found in the study area.</p> <p>16. Soil mining shall strictly be undertaken as per rules and regulations/permissions obtained from District Administration/Mining Department</p> <p>23. A copy of resolution as above shall be submitted to the authority along with list of beneficiaries with their mobile nos./address.</p> <p>24. The borrowing/excavation activity shall be restricted to a maximum depth of 2 m. below general ground level at the site.</p> <p>25. The borrowing/excavation activity shall be restricted to 2 m. above the ground water table at the site.</p> <p>26. The borrowing/excavation activity shall not alter the natural drainage pattern of the area.</p> <p>27. The borrowed/excavated pit shall be restored by the project proponent for useful purpose(s).</p> <p>28. The lease holder shall mandatorily follow all the imposed conditions otherwise it will amount to violation of E.C. conditions. The mining lease holders shall ensure to comply with mine reclamation plan as submitted</p> <p>5. If the proposed project is situated in notified area of ground water extraction, where creation of new wells for ground water extraction is not allowed, requirement of fresh water shall be met from alternate water sources other than ground water or legally valid source and permission from the competent authority shall be obtained to use it.</p> <p>6. Project Proponent should submit action plan for carrying out plantation at least @1,000 plants / ha of lease area. In this case, PP should prepare a plan, duly approved either by Forest Department or district plantation committee, for planting at least 1,000 plants, either on government land or community land, within a periphery of 5 km from the boundary of the lease area along with provision for maintenance for 5 years. Also, the coordinates of area earmarked for plantation should be clearly spelt and polygon should be attached and submitted within a month. Survival of plants should not be less than the survival rate notified by Uttar Pradesh Forest Department otherwise it will be treated as violation of EC condition.</p> <p>7. The project proponent shall ensure that water bodies do not get polluted due to mining activity.</p> <p>8. Department of Geology and Mines, Government of Uttar Pradesh and / or concerned district administration, before releasing the security deposit to Project Proponent will ensure that Project Proponent has fully complied with the EC conditions. Non-compliance, if any, should be reported to UPSPCB for appropriate legal action and recovery of compensation.</p>

Any application for transfer of this EC, during its validity period unless it is cancelled by a competent authority, has to be necessarily accompanied with status of compliance of EC conditions duly certified by IRO, MoEFCC, GoI, Lucknow.</p> <p>10. The project proponent shall install rooftop solar plant in one school in the vicinity of project area and construct toilets especially in girls' school as part of CER activity.</p> <p>11. Project Proponent shall submit the Six-monthly Compliance on the Environment Clearance condition prescribed in the Prior Environment Clearance letter as per MoEF&CC OM F.no- IAS-22/01/2022-IA-III (E-172624) Dated 14-06-2022.</p> <p>12.
