This is in reference to your application submitted to SEIAA vide proposal number SIA/TN/MIN/467065/2024 dated 25/03/2024 for grant of prior Environmental Clearance (EC) to the project Proposed Rough Stone quarry over an extent of 2.00.0 Ha (Government Poramboke Land) at S.F.No. 606/4(Part) of Kambur Village, Melur Taluk, Madurai District, Tamil Nadu under the provision of the EIA Notification 2006-and as amended thereof.

3. In view of the particulars given in the Para 1 above, the project proposal interalia including Form-2(Part A, B ) Reports were submitted to the SEIAA for an appraisal by the SEAC under the provision of EIA notification 2006 and its subsequent amendments.
4. The above-mentioned proposal has been considered by SEIAA in the meeting held on 29/05/2024. The minutes of the meeting and all the project documents are available on PARIVESH portal which can be accessed from the PARIVESH portal by scanning the QR Code above. Brief description of the project is as under:
5. The SEAC, based on information submitted viz: Form 2 (Part A, B ) report etc., & clarifications provided by the project proponent and after detailed deliberations on all technical aspects and public hearing issues and compliance thereto furnished by the Project Proponent, recommended the proposal for grant of Environment Clearance under the provision of EIA Notification, 2006 and as amended thereof subject to stipulation of Specific and Standard EC conditions as detailed in the point below.
6. The SEIAA has examined the proposal in accordance with the provisions contained in the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and based on the recommendations of the SEAC hereby accords Environment Clearance for the instant proposal to Thiru. S. Muthukaruppasamy, under the provisions of EIA Notification, 2006 and as amended thereof subject to compliance of the Specific and Standard EC conditions as given in Annexure (2)
7. The Ministry reserves the right to stipulate additional conditions, if found necessary.
8. The Environmental Clearance to the aforementioned project is under provisions of EIA Notification, 2006. It does not tantamount to approvals/consent/permissions etc. required to be obtained under any other Act/Rule/regulation. The Project Proponent is under obligation to obtain approvals /clearances under any other Acts/ Regulations or Statutes, as applicable, to the project.

#### 11. General Instructions:

1. The project proponent shall prominently advertise it at least in two local newspapers of the District or State, of which one shall be in the vernacular language within seven days indicating that the project has been accorded environment clearance and the details of SEIAA website where it is displayed.
2. The copies of the environmental clearance shall be submitted by the project proponents to the Heads of local bodies, Panchayats and Municipal Bodies in addition to the relevant offices of the Government who in turn must display the same for 30 days from the date of receipt.
3. The project proponent shall have a well laid down environmental policy duly approved by the Board of Directors (in case of Company) or competent authority, duly prescribing standard operating procedures to have proper checks and balances and to bring into focus any infringements/deviation/violation of the environmental / forest / wildlife norms / conditions.
4. Action plan for implementing EMP and environmental conditions along with responsibility matrix of the project proponent (during construction phase) and authorized entity mandated with compliance of conditions (during operational phase) shall be prepared. The year wise funds earmarked for environmental protection measures shall be kept in separate account and not to be diverted for any other purpose. Six monthly progress of implementation of action plan shall be reported to the Ministry/Regional Office along with the Six-Monthly Compliance Report.
5. Concealing factual data or submission of false/fabricated data may result in revocation of this environmental clearance and attract action under the provisions of Environment (Protection) Act, 1986.
6. The Regional Office of this SEIA A shall monitor compliance of the stipulated conditions. The project authorities should extend full cooperation to the officer (s) of the Regional Office by furnishing the requisite data / information/monitoring reports.
7. Any appeal against this EC shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.

#### 1. Seac Conditions - Site Specific

1.1	<ol style="list-style-type: none"><li>1) The prior Environmental Clearance granted for this mining project shall be valid for the project life including production value as laid down in the mining plan approved and renewed by competent authority, from time to time, subject to a maximum of thirty years, whichever is earlier, vide MoEF&amp;CC Notification S.O, 1807(E) dated 12.04.2022.</li><li>2) The PP shall mark the DGPS reference pillars painted with blue &amp; white colour indicating the safety barrier of 7.5 m to be left under the Rule 13 (1) of MCDR, 1988 within the lease boundary and protective bunds, before obtaining the CTO from the TNPCB.</li><li>3) The PP shall <b>register promptly through online in the Shram Suvidha Portal</b> which is the official portal of Ministry of Labour &amp; Employment, Govt of India to obtain <b>Labour Identification Number (LIN) before obtaining the CTO from the TNPCB.</b></li><li>4) The prior Environmental Clearance granted for this mining project shall be valid only for carrying out manual mining operation in the proposed quarry/mine as stipulated in the mining plan approved by competent authority.</li><li>5) As accepted by the Project Proponent the CER cost of <b>Rs. 5 Lakhs</b> and the amount shall be spent for the activities as committed towards Panchayat Union Primary School, Veerasudamanipatti Village, Melur Taluk, Madurai District, before obtaining CTO from TNPCB.</li><li>6) Tree plantation &amp; fencing and installation of garland drainage with siltation tank around the mine lease area shall be completed before execution of the mine lease.</li><li>7) The PP shall furnish an affidavit indicating the Standard Operating Procedures (SoP) for carrying out the 'Best Mining Practices' in the areas of drilling, rock breaking, excavation, transportation, and green belt development, in securing the safety of the persons living within a radial distance of 500 m (danger zone) to the concerned AD (Mines) at the time of lease execution.</li><li>8) The PP shall <b>annually</b> carry out an Occupational Health Survey (OHS) <b>in accordance with the guidelines &amp; period of examination laid in the DGMS (Tech.) (S&amp;T) Circular No. 01 of 2011</b>, on OHS of the persons working in mines prone to generate the airborne dust, under Section 9A of Mines Act, 1952 by actively involving State Government officials and Non-Government Organizations(NGO) working in the Occupational Health Survey (Medical Examination). A copy of such annual compliance certificate shall be submitted to the SEIAA, MoEF, TNPCB, AD/Mines-DGM and DMS, Chennai as a part of Environmental Compliance without any deviation.</li></ol>

## 2. Air Quality Monitoring And Mitigation Measure

2.7	Adequate number of Fog canon (mist sprayer) shall be installed to reduce the impact of air pollution at dust generating sources with time bound action plan.

### 3. Water Quality Monitoring And Mitigation Measures

3.4	Ground water, excluding mine water, shall not be used for mining operations. Rainwater harvesting shall be implemented for conservation and augmentation of ground water resources.
3.5	The project proponent shall not alter major water channels around the site. Appropriate embankment shall be provided along the side of the river/nallah flowing near or adjacent to the mine. 5.5	No mining shall be carried out in forest land without obtaining Forestry Clearance as per Forest (Conservation) Act, 1980 and also adhering to The Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 read with provisions of Indian Forest Act, 1927.
5.6	Efforts should be made to reduce energy and fuel consumption by conservation, efficiency improvements and use of renewable energy.

#### 6. Land Recalvation
