In view of the particulars given in the Para 1 above, the project proposal interalia including Application for Amendment in EC were submitted to the SEAC, Odisha for an appraisal by the State Expert Appraisal Committee (SEAC) under the provision of EIA notification 2006 and its subsequent amendments.

2. The above-mentioned proposal has been considered in 189th Meeting of State Environment Impact Assessment Authority meeting held from 07/02/2025. Based on the recommendations of the State Expert Appraisal Committee,

Odisha (SEAC, Odisha), information & clarifications provided by the project proponent and after detailed deliberations the Authority decided “After detailed deliberation, the authority decided to reject the proposal as recommended by SEAC due to the following:-

- a) No Ground Control Points Taken.
- b) No Permanent bench mark is taken.
- c) No error report of Drone survey given.
- d) Elevation in pre monsoon survey ranges from 7.53 m to 16.41 m and in post monsoon ranges from 7.95 to 14.05m as per details given. It appears to be unrealistic for the given area.”

Therefore, the proposal for Amendment in EC is Rejected as per provision of EIA Notification, 2006 and as amended thereof.
