This is in reference to your application submitted to Ministry vide proposal number SIA/OR/MIN/483637/2024 dated null for Rejection of prior Environmental Clearance (EC) to the project under the provision of the EIA Notification 2006-and as amended thereof.

1. In view of the particulars given in the Para 1 above, the project proposal interalia including Application for Amendment in EC- Form-4 were submitted to the SEAC, Odisha for an appraisal by the State Expert Appraisal Committee (SEAC) under the provision of EIA notification 2006 and its subsequent amendments.

2. The above-mentioned proposal has been considered by State Environmental Impact Assessment Authority, Odisha (SEIAA, Odisha) in 174th meeting held on 13/08/2024. Based on the recommendations of the State Expert Appraisal

Committee, Odisha (SEAC, Odisha), information & clarifications provided by the project proponent and after detailed deliberations the Authority decided "The Authority agreed with the recommendation of SEAC and rejected the Amendment of EC proposal as the ARRS report is not done as per MoEF & CC, Govt. of India guidelines. The details SEAC observation as follows:

(i) In RSR pre-monsoon and post-monsoon safe workable area is mentioned as 2596 sqm and 8335 sqm respectively, Common safe workable area is mentioned as 5746 sqm. The reason for common safe workable area exceeding the minimum of two areas needs to be explained.

(ii) There is a calculation in RSR as follows; "So, replenishment of sand in workable area = $4018 \text{ (m}^3\text{)} / 0.7652 \text{ (ha)} = 5251 \text{ m}^3$." This calculation is wrong and confusing.

(iii) The RSR quantity calculation needs to be resubmitted complying to above".

Therefore, the proposal for Amendment in EC is Rejected as per provision of EIA Notification, 2006 and as amended thereof.
