3.In view of the particulars given in the Para-1 above, the project proposal interalia including Form-4 (Part A, B & C) were submitted to the SEAC for an appraisal by the State Level Expert Appraisal Committee (SEAC) under the provision

of EIA notification 2006 and its subsequent amendments thereto.

4.The above-mentioned proposal has been considered by SEAC in its meeting held on 02.05.2024. The minutes of the meeting and all the project documents are available on Parivesh portal which can be accessed from the Parivesh portal by scanning the QR Code above or through the following web link [click here](#).

5.The brief about the reasons for an amendment requested along with the brief on the salient features of the project as submitted by the project proponent in Form- 4 (Part A, B & C) and as presented before SEAC and the details of the amendment of EC are annexed as **Annexure- 2**.

6.The proposal was placed in the SEAC meeting held on 02.05.2024 under the provisions of EIA Notification 2006 and its subsequent amendments and after detailed deliberations in the matter and the SEAC decided to recommend the proposal for extraction quantity of sand 28177cum based on replenishment study report submitted by the project proponent through consultant.

7.The SEIAA, Odisha has examined the proposal in 168th meeting held on 24.06.2024 & 25.06.2024 in accordance with the extant provisions of the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and based on the recommendations of the SEAC, hereby accords amendment in Environment Clearance (EC) letter no./Identification no. 562/SEIAA dt. 15.02.2021 issued for Borda-1 River Sand Quarry in favour of Sri Sanjeeb Kumar Bhoi is **allowed** for extraction quantity of sand **28177 cum per annum** for the balance lease period under the provisions of EIA Notification, 2006 and as amended thereof subject to compliance of EC conditions, general instructions issued vide EC letter dated 15.02.2021 and following additional specific conditions as mentioned in **Annexure-1**.



**Annexure 1**

#### **Additional EC Conditions**

1. The extraction quantity of sand may be allowed after approval of revised mining plan based on replenishment of sand by competent Authority.
2. The PP is required to carry out the Annual rate of replenishment study (ARRS) through ORSAC empanel agency in subsequent years and submit the report to SEIAA, Odisha.
3. The validity of EC is for validity of DSR or validity of lease period whichever is earlier.
4. The Project Proponent (lease holder) shall deposit **Rs.2,00,000/-**, with the respective District Environment Society for raising **400** plants (minimum @100 trees per Ha) of native species within 2 years in a suitable location adjoining the quarry.

5. The PP will implement the EMP with a budgetary allocation as proposed in the EMP report during EC application.
6. The Project Proponent shall upload/submit six monthly EC compliance in the Parivesh Portal of MoEF & CC., Govt. of India only within six months (06) from date of issue of amendment of EC, failing which the EC is liable to be revoked.



**1. Proposal in brief:**

The highlights of the proposal as ascertained from the application and as revealed from proceedings/discussion held during the meeting of SEAC/SEIAA, are given as under.

- (i) This is a proposal for amendment of EC of Borda-1 Sand Bed over an area of 7.88 acres or 3.188 hectares in Village Borda under Kalahandi Tahasil of Kalahandi District, Odisha.
- (ii) The project proponent has obtained EC from SEIAA, Odisha vide EC letter no. /EC Identification No. – 562/SEIAA dt. 15.02.2021 & EC transfer on 04.03.2024 for Borda-1 Sand Bed over an area of 7.88 acres or 3.188 hectares in Village Borda under Kalahandi Tahasil of Kalahandi District, Odisha.
- (iii) During EC application the PP has submitted required documents along with mining plan where it is mentioned that mineable reserve of the proposed sand was 16391 cum with depth of sand deposition was 1.0 meter and proposed for annual extraction-3000 cum.
- (iv) The SEIAA allowed 3000 cum of sand for 1<sup>st</sup> year lease period with allowing depth of mining is 1.0 meter.
- (v) There is an EC conditions point no. 9.1 to 9.2 in page no. 03 that “Pending carrying out of the study & submission of the report, this clearance is being granted in an adhoc manner and is liable to be revoked after one year i.e., after 15<sup>th</sup> May 2022, if satisfactory replenishment study report is not submitted.”
- (vi) The PP has mentioned that 3000 cum of sand has been extracted from the source in 1<sup>st</sup> year lease period.
- (vii) The PP has submitted replenishment study report was done by the AREAL CONSTRUCTIONS & GEO -INDIA SERVICES, the ORSAC empanel agency with mentioned that Pre-Monsoon Standard Elevation = 202.3428 , Post-Monsoon Standard Elevation = 203.7964 and quantity of sand replenished is **28177.8324 cum** and proposed production 16906.6994 cum.
- (viii) Any deficiencies/omission have been noticed in the above documents-The PP has not complied the transfer of EC condition in respect to amount to be deposited for raising plantation and lease area demarcation.

**2. Whether SEAC recommended the proposal** – The proposal was placed in the SEAC meeting held on 02.05.2024 and the SEAC **recommended** the following: Annual mining plan capacity was 3000 m<sup>3</sup>/yr and EC was given for same in 1st year. As per RS, PP has estimated safety mineable area as 19384.86 and differential elevation of 1.4 mt. Multiplying the RS quantity arrived as 28177.8 m<sup>3</sup> against approved mining quantity of 16391 m<sup>3</sup>. EC may be recommended for the replenishment quantity subject to modified mining plan approval of derived replenishment quantity and modified annual mining capacity by the authority.
