3. In view of the particulars given in the Para-1 above, the project proposal interalia including Form-7 were submitted to the SEAC for an appraisal by the State Environment Impact Assessment Authority (SEIAA), Odisha under the provision of Para-11 of the EIA notification 2006 and its subsequent amendments thereto. Details in Form-7 can be accessed on the PARIVESH portal by scanning the QR Code above.
4. The SEIAA, Odisha has examined the proposal along with requisite information/documents required for transfer of EC in 173rd meeting held on 06.08.2024 & 08.08.2024 in accordance with the provisions contained in the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and hereby accord transfer of EC letter no. EC23B001OR182946 dt. 17.01.2023 of Padampuri Stone Quarry -7 **is allowed** to Sri Santosh Kumar Sahu, the successful bidder as per the request of Mining Officer, Nuapada vide letter no. 413 dated 09.07.2024 under the provisions of EIA Notification, 2006 and as amended thereof. The production quantity of stone **3040 cum/annum** upto the validity of DSR or validity of the lease period whichever is earlier. The other stipulated terms and conditions of the original EC initially granted on 17.01.2023 remain same subject to satisfactory compliance to all the stipulated terms and conditions of EC issued vide EC letter dated 17.01.2023 along with following additional specific conditions as mentioned below.
5. The SEIAA, Odisha may revoke or suspend the clearance, if implementation of any of the EC conditions is not satisfactory. The SEIAA reserves the right to stipulate additional conditions, if found necessary.
6. The PP is under obligation to implement commitments made in the Environment Management Plan, which forms part of the prior EC issued vide dated 17/01/2023.
7. This issue with the approval of the Competent Authority.



Additional EC Conditions

1. The validity of EC is for validity of DSR or validity of lease period whichever is earlier.
2. Boundary Demarcation: - The boundary of the lease area shall be demarcated on ground at the project cost, by erecting 1.20 meter (4 feet approx.) high reinforced concrete pillars above ground, each inscribed with its serial number, distance from pillar to pillar and GPS co-ordinates by any empanelled agency of ORSAC.
3. Digital Map: -A digital map (in KML format as well as PDF version) showing GPS coordinates of all boundary pillars duly countersigned by the concerned lease granting Authority Tahasildar/Mining Officer shall be submitted to SEIAA, Odisha through email at info.seiaaodisha@gmail.com.
4. Intimation of EC: -The copies of the EC shall be sent to the Sarpanch (s) of the concerned Gram Panchayat (s), Urban Local Bodies and relevant other Offices of the Government with a request to display the same for 30 days from the date of receipt.

- 5. The PP shall expend the amount provision for EMP and submit it in a six-monthly compliance report.
- 6. The Project Proponent/lessee shall upload/submit six monthly EC compliance in the Parivesh Portal of MoEF & CC., Govt. of India only on half-yearly basis falling which the EC is liable to revoke.
- 7. In case, there is a change in the scope of the project, fresh Environment Clearance shall be obtained.



1. Proposal in brief:

The highlights of the proposal as ascertained from the application and as revealed from proceedings/discussion held during the meeting of SEIAA, are given as under.

- i) This is a proposal Transfer of EC of Padampuri Stone Quarry -7 over an area of 2.023 Ha bearing Khata no.- 76 and Plot No.- 187 in village/Mouza- Padampuri, Tahasil/District- Nuapada.
- ii) Documents submitted: Application in Form-7, earlier EC copy, forwarding letter, Status of quarry and scrutiny of Rs. 1000/- vide e-Challan Ref. No. 380B87304F dated 11.07.2024.
- iii) The EC of Padampuri Stone Quarry -7 over an area of 2.023 Ha bearing Khata no.- 76 and Plot No.- 187 in village/Mouza- Padampuri, Tahasil/District- Nuapada was in favour of Tahasildar, Nuapada vide SEIAA letter no./Identification No. EC23B001OR182946 dt. 17.01.2023.
- iv) Present status of quarry- working
- v) Whether submitted KML file-Yes
- vi) The project proponent applied proposal for transfer of EC from the name Tahasildar, Nuapada to Sri Santosh Kumar Sahu, (highest bidder/lessee) with attaching forwarding letter of Mining Officer, Nuapada vide letter no. 413 dated 09.07.2024.
- vii) Any deficiencies/omission have been noticed in the above documents-**Nearest Railwayline is located 150 meter and NH is 170 m away from the quarry boundary.**
- viii) The PP has deposited the amount of Rs. 90,000/- to the District Environment Society, Nuapada for raising tree plantation as per per EC conditions.
