The SEAC, in its meeting held on 20/11/2024, based on information & clarifications provided by the project proponent (PP) observed that the plot area for the proposed project as per the geo-coordinates mentioned in the PFR uploaded by the PP, falls outside the potential mining zone recorded in the approved District Survey Report (DSR) of Purba Bardhaman district. After detailed deliberations recommended the proposal for Rejection of Environment Clearance and forwarded to SEIAA for rejection under the provision of EIA Notification, 2006 and as amended thereof.

The SEIAA has examined the proposal in accordance with the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and after accepting the recommendations of the State Expert Appraisal Committee hereby decided to Reject Environment Clearance for instant proposal of M/s. SHAON BHOWAL under the provisions of EIA Notification, 2006 and as amended thereof.
