The SEAC, Gujarat vide their MoM dated **24/09/2024** had recommended to SEIAA, Gujarat to reject your application seeking EC. Your proposal was considered by the SEIAA, Gujarat in its meeting held on **09/11/2024 & 11/11/2024** at Gandhinagar.

After careful consideration, your application for EC is hereby rejected under the provisions of the EIA Notification dated 14th September, 2006 as recommended by SEAC for the following reason.

1. Proposed lease is about 200 meter away from the Bridge which do not comply with the sitting criteria i.e Sustainable Sand Mining Management Guidelines-2016 of MOEF&CC and Enforcement and Monitoring Guidelines for Sand Mining –January-2020 of MoEF&CC.
